BACKGROUND:

The State Lands Commission has received a request from the City of Pittsburg to approve the boundaries and consent to the annexation of the Riverview Marina Annexation, as required by Government Code Sections 56108.

Pursuant to Government Code Section 56108(c) and (d), whenever State-owned tidelands and submerged lands are included within a proposed annexation, the Commission is to review and approve or deny the proposed annexation boundaries as appropriate and correct. The Commission must act within 45 days following receipt of the request for approval by the project proponent.

The area proposed for annexation includes approximately 9.46 acres of land, more or less. The subject area is initially tidelands and submerged lands in the bed of the Sacramento River adjacent to the city limits of the City of Pittsburg.

The proposed annexation includes tide and submerged lands that are currently under lease to the City of Pittsburg for the Riverview Marina. Review of the file uncovered a discrepancy between the lease and the existing project to be annexed. The lease must be amended to cover the existing project.
