Patented tidelands and State-owned submerged
land lying beneath existing facilities at
No. 34 Sandy Beach Road, Vallejo, Solano County.

LAND USE:

Maintenance of existing recreational and
residential structures and other appurtenant
facilities.

TERMS OF PERMIT:

Initial period: 20 years beginning
September 22, 1980.

Public liability insurance: Combined single
limit coverage of \$100,000.

Consideration: \$78.39 per annum, for the
area waterward of the
surveyed low water line;
five-year rent review.

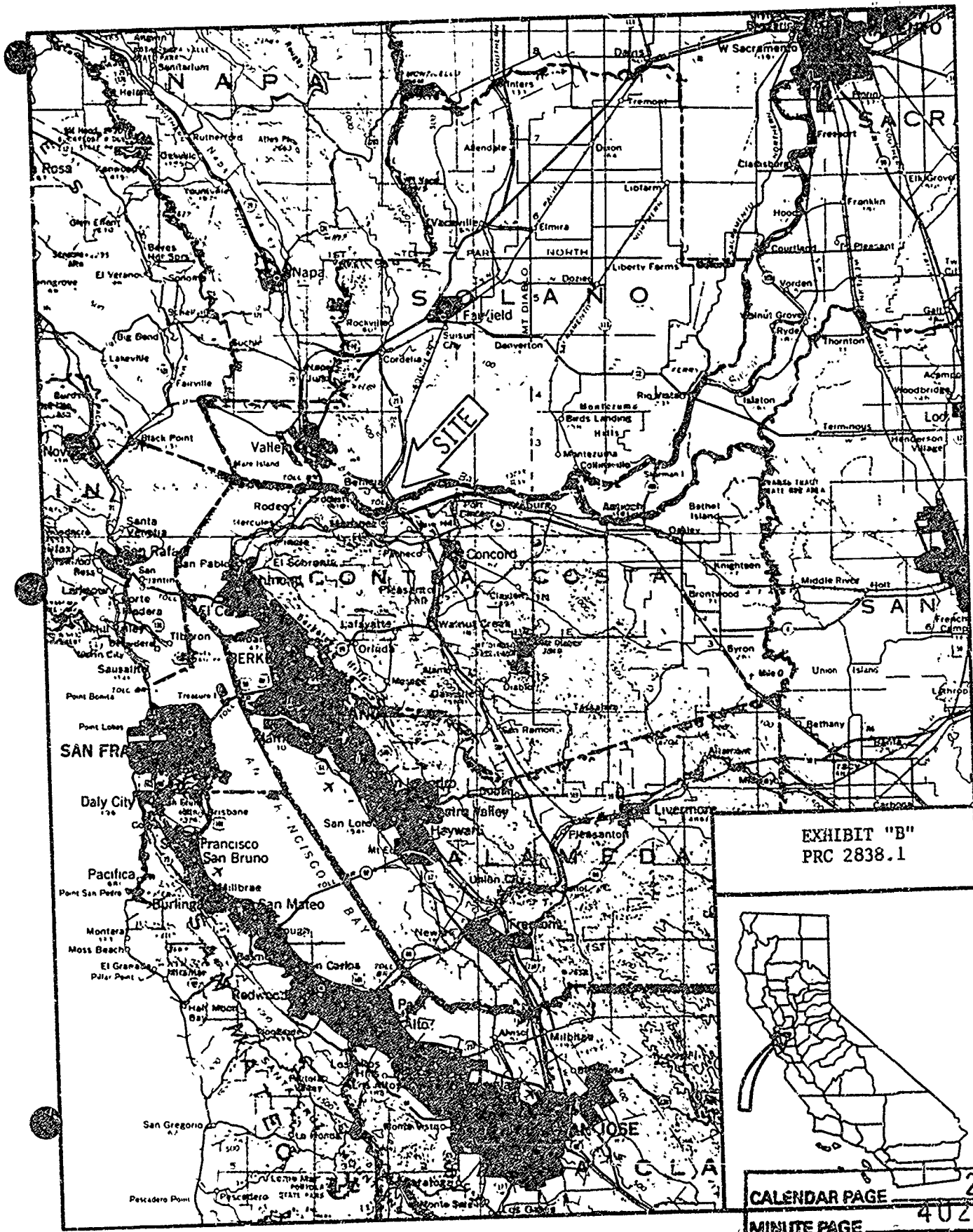
