TERMINATION OF SALVAGE PERMIT

APPLICANT: Maurice A. Enderle
dba: The Enderle Group

AREA, TYPE LAND AND LOCATION:
A two-acre parcel of sovereign land within the
bed of Owens Lake, vicinity of Bartlett, Inyo
County.

LAND USE: Salvage of silver and artifacts from a sunken
vessel, or vessels, at Owens Lake.

TERMS OF ORIGINAL PERMIT:
Initial period: One year beginning January 1,
1989.
Surety bond: \$5,000.
Public liability insurance: Combined single
limit coverage of \$500,000.
Consideration: \$50 per annum.

- 1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: P.R.C. 21065 and 14 Cal. Code Regs. 15378.

- 2. The permittee has requested that his salvage permit be terminated as he has not worked, nor will he be able to work, at this project site during the current year. The salvage permit was issued for State lands subject to a mineral lease issued to the Lake Minerals Corporation. Bill McClung of Lake Minerals has inspected the site of the salvage operations and has determined that the restoration of the site is acceptable and will not impact his mineral lease. Therefore, staff recommends that the salvage permit be terminated effective November 1, 1989.

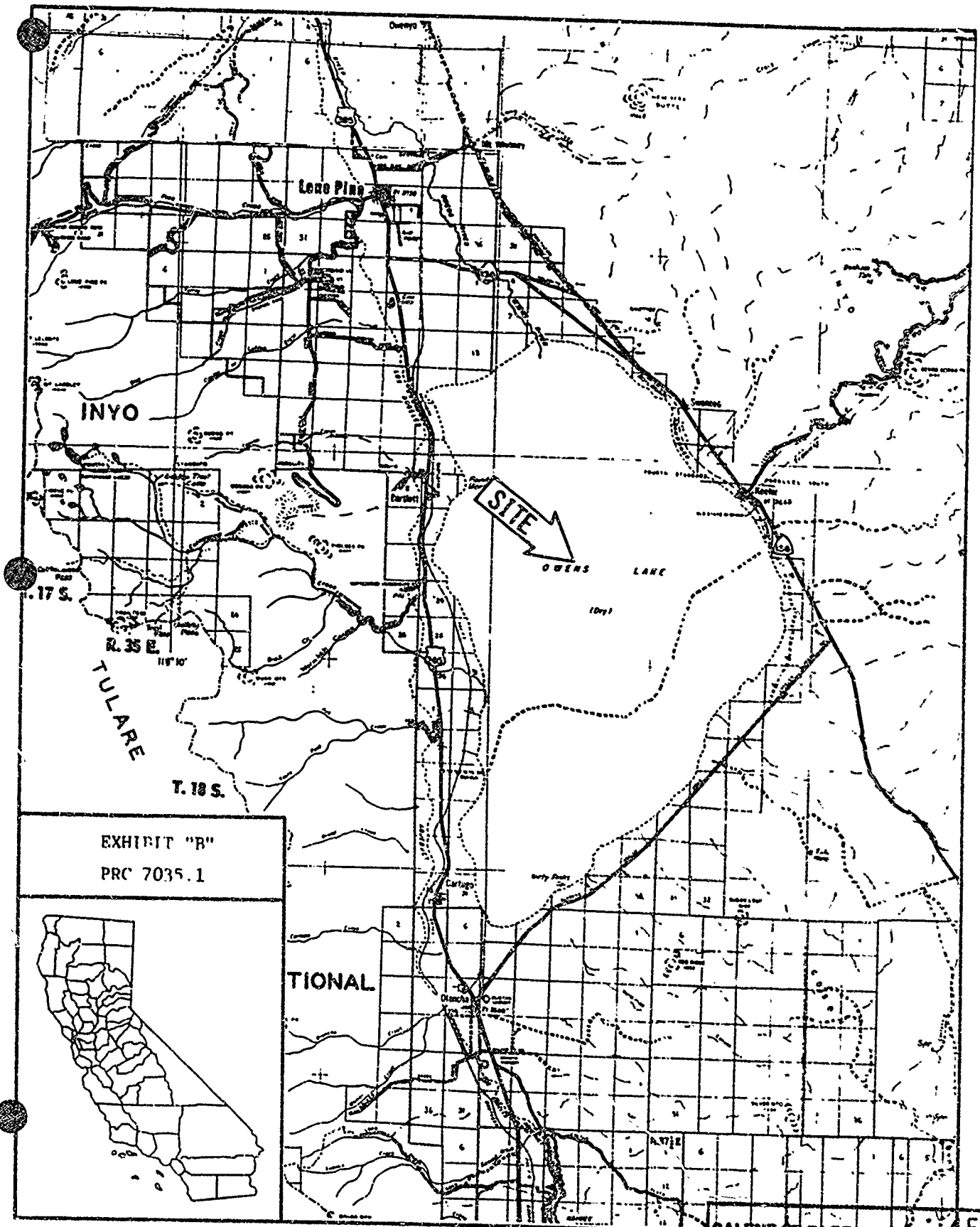
