**MERCED COUNTY**

The State Lands Commission is a party to three related condemnation actions brought by the United States Attorney entitled, U.S.A. v. 104.32 Acres of Land, More or Less [U.S.D.C. E.D. Ca #89-436], U.S.A. v. 1261.21 Acres, More or Less [U.S.D.C. E.D. Ca #89-582] and U.S.A. v. 294.10 Acres, More or Less [U.S.D.C. E.D. Ca #89-586] involving land in Merced County to be used in connection with Castle Air Force Base operations.

Upon examination of the Commission's record pertinent to the area, it has been ascertained that there is no interest held by the State Lands Commission in the tracts of lands described in the Complaint in Condemnation filed in the above-referenced actions and properly served on the Commission.

Inasmuch as these suits involve lands over which the Commission exercises no jurisdiction, it is recommended that a disclaimer be filed in each case on behalf of the State Lands Commission disclaiming any compensable right, title, or interest in the tracts of land described in said condemnation actions.

2. AUTHORIZE THE ATTORNEY GENERAL TO FILE DISCLAIMERS ON BEHALF OF THE STATE LANDS COMMISSION IN THE CASES OF UNITED STATES OF AMERICA v. 104.33 ACRES OF LAND, MORE OR LESS, ET AL, [U.S.D.C. E.D. Ca #89-436], UNITED STATES OF AMERICA v. 1261.21 ACRES OF LAND, MORE OR LESS, ET AL, [U.S.D.C. E.D. Ca #89-582] AND UNITED STATES OF AMERICA v. 294.10 ACRES OF LAND, MORE OR LESS, ET AL, [U.S.D.C. 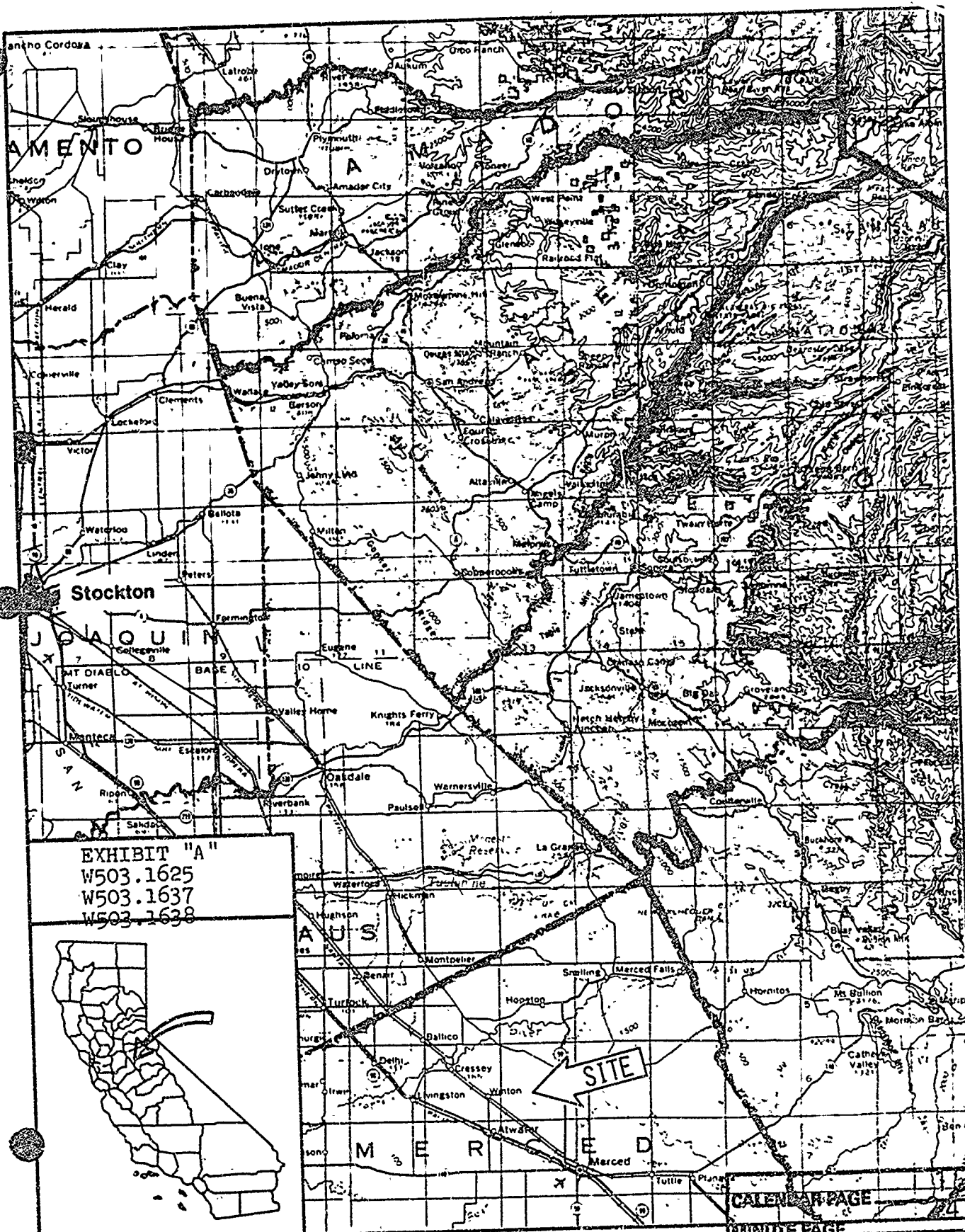
