AUTHORIZATION TO STIPULATE TO FINAL JUDGMENT  
IN UNITED STATES OF AMERICA v. 75.45 ACRES  
OF LAND, MORE OR LESS, SITUATE IN THE  
COUNTY OF CONTRA COSTA, STATE OF CALIFORNIA,  
ET AL, UNITED STATES DISTRICT COURT FOR THE  
NORTHERN DISTRICT OF CALIFORNIA, CIVIL NO.  
C-80-1903 WWS

This condemnation involves filled and unfilled State owned tidelands and submerged lands in the Carquinez Straits which are occupied by an existing wharf used for off-loading jet fuel. These lands are described in Exhibit "A" and shown on site map, Exhibit "B", attached hereto. These lands were leased by the Commission to the Holly Corporation under PRC 2408. That lease expired on May 27, 1979 and Holly remained in holdover status until May 1980. At that time, the Federal Government took control of the facility pursuant to this condemnation.

The condemnation includes uplands, tidelands, and submerged lands. A portion of the condemnation parcel was included within State Tideland Sale No. 32; Commission staff has disputed the validity of that sale on the grounds that it violated the Constitutional prohibition against sales of tidelands within two miles of a town or village (Martinez), and because it purported to convey lands which were in fact submerged lands. The State therefore claims an interest in those condemnation parcels which lie waterward of the last natural location of the ordinary high water mark; specifically, Tracts 102, 109, and 110.

Staff of the Commission and the Attorney General's office have been negotiating with representatives of the United States Attorney and the Army Corps of Engineers in an attempt to resolve issues concerning the State's interest in this condemnation. A settlement proposal, which consisted of an exchange of land between the State and Federal Government, was presented to the Commission at its September 26, 1985 meeting and approved as Minute Item No. 31. Subsequent to the Commission's approval of the settlement, the Federal Government determined it was unable to carry through with the proposed land exchange. Continued negotiations have resulted in the following settlement proposal:

- 1) The United States will take, via the condemnation, all of the State's right, title, and interest in Tract 102, 109 and 110. This taking will be subject to the conditions that the property will not be used for non-federal purposes or commercial concessions, other than marine terminal uses, without the prior written permission of the Commission. The United States does not anticipate commercial use at this time.
- 2) In settlement of the State's claimed sovereign interests taken by the United States in the condemnation, as described in the Stipulation for Final Judgement on file in the office of the Commission, the U.S. will pay the sum of \$262,500 into the Kapiloff Land Bank Fund. Staff has conducted an appraisal of its interests in Tracts 102, 109, and 110, and has determined that the value of the interests to be given up by the State is equal to or less than \$262,500.

The approval of this Settlement does not have any potential for resulting in a physical change in the environment and therefore is not a project as defined by the CEQA.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 BECAUSE THE ACTIVITY IS NOT A PROJECT AS DEFINED BY PRC 21065 AND 14 CAL. ADM. CODE 15378.
2. FIND THAT IT IS IN THE BEST INTERESTS OF THE STATE TO ENTER INTO THE STIPULATION FOR FINAL JUDGMENT ON FILE IN THE OFFICES OF THE STATE LANDS COMMISSION AND THAT THIS SETTLEMENT WILL AVOID THE COSTS, DELAYS, AND UNCERTAINTIES OF LITIGATION.
3. FIND THAT THE SETTLEMENT EMBODIED IN THE STIPULATION OF FINAL JUDGMENT ON FILE IN THE OFFICES OF THE STATE LANDS COMMISSION IS CONSISTENT WITH THE REQUIREMENTS OF LAW AND PROVIDES COMPENSATION FOR THE TAKING OF STATE-OWNED INTERESTS IN TIDELANDS AND SUBMERGED LANDS EQUAL TO THE VALUE OF THOSE INTERESTS IN THOSE LANDS.
4. AUTHORIZE THE CALIFORNIA ATTORNEY GENERAL TO EXECUTE THE STIPULATION FOR FINAL JUDGMENT SUBSTANTIALLY IN THE FORM ON FILE IN THE OFFICES OF THE STATE LANDS COMMISSION, AND MAKE NECESSARY APPEARANCES ON BEHALF OF THE STATE LANDS COMMISSION, IN THE CASE OF UNITED STATES OF AMERICA v. 75.45 ACRES OF LAND, MORE OR LESS, SITUATE IN THE COUNTY OF CONTRA COSTA, STATE OF CALIFORNIA, ET AL, UNITED STATES DISTRICT COURT, NORTHERN DISTRICT OF CALIFORNIA, CIVIL NO. C-08-1903 WWS.
5. AUTHORIZE AND DIRECT THE STAFF OF THE STATE LANDS COMMISSION, AND/OR THE CALIFORNIA ATTORNEY GENERAL, TO TAKE ALL NECESSARY OR APPROPRIATE ACTION ON BEHALF OF THE STATE LANDS COMMISSION TO CONSUMMATE THE SETTLEMENT EMBODIED IN THE STIPULATION FOR FINAL JUDGMENT ON FILE IN THE OFFICES OF THE STATE LANDS COMMISSION.

EXCEPTING THEREFROM any portion of Parcel One or Parcel Two lying landward of the ordinary high water mark.

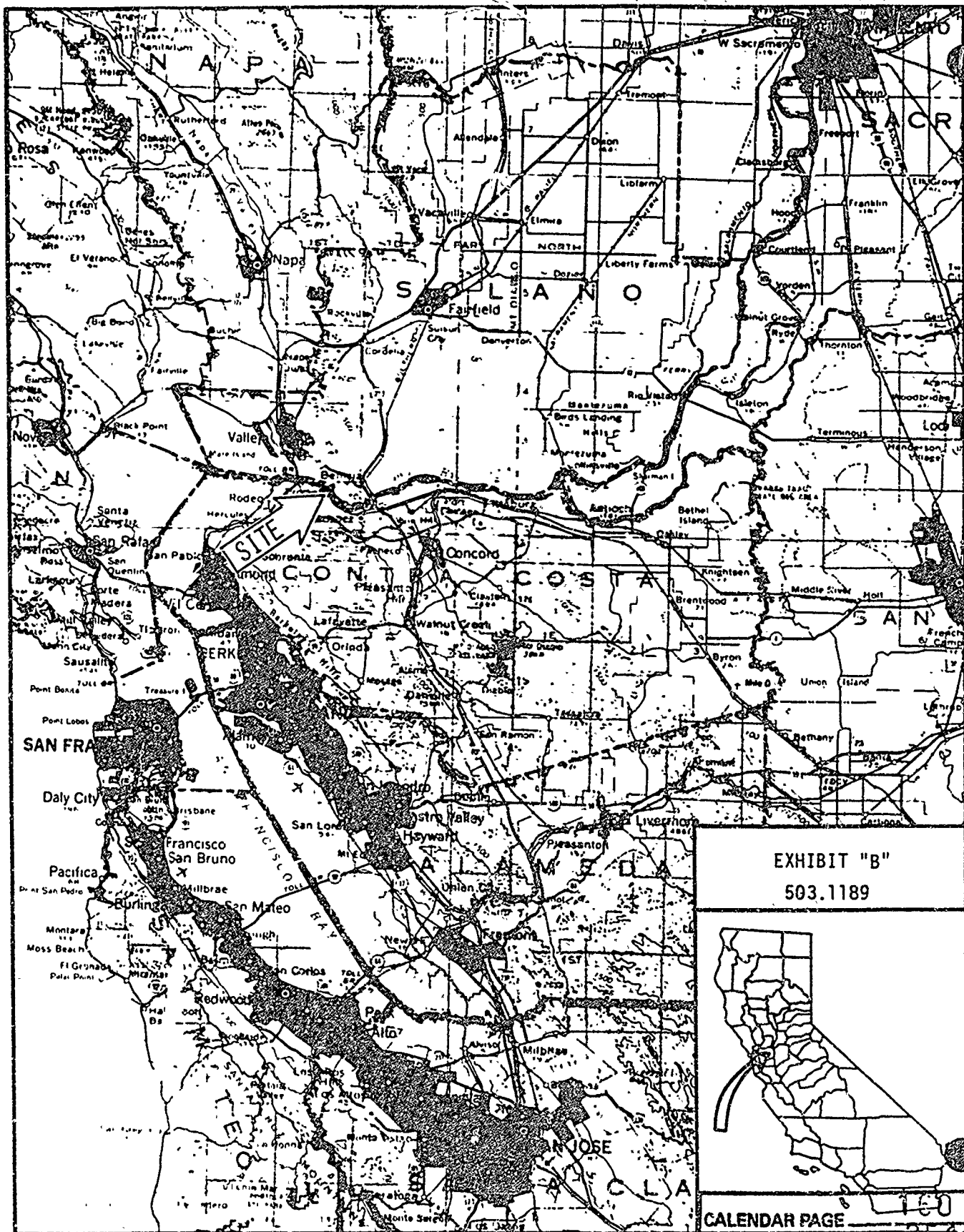
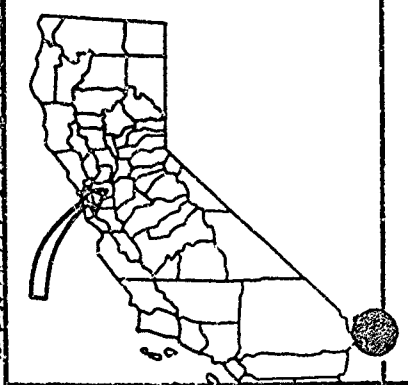
