On June 30, 1988, the Commission granted prior approval to the City of Long Beach for \$250,000 in subsidence cost expenditures to be used in the conduct of vertical and horizontal measurements and studies in the Long Beach Harbor District during the 1988-89 fiscal year. The work consists of analysis and interpretation of data developed from twice yearly elevation and linear surveys carried out through an established network of ground control points dispersed throughout the project area. The purpose is to detect the occurrence, if any, of subsidence of the land surface. The vertical (elevation) surveys are conducted each May and November and the horizontal (linear) surveys are conducted each February and August. No significant change in the Harbor District land surface was detected during 1988-89.

Expenditures for the vertical measurements and studies were less than the prior approved amount by \$47,062.76. The cost of the horizontal measurements, and studies was less than the amount approved by \$6,951.30. A staff audit confirms the incurred charges. The cost savings were due primarily to efforts by the Harbor Department survey staff to reduce expenditures by applying state of the art technology and the elimination of a number of redundant bench marks.

 Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the Commission's review of this activity is exempt from the requirements of the CEQA because it is not a "project" as defined by CEQA and the State CEQA Guidelines.


