RATIFY FIFTH MODIFICATION OF THE 1989-90
PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET,
LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY

The City of Long Beach has requested approval of the Fifth Modification of the 1989-90 Plan of Development and Operations and Budget, Long Beach Unit. Under the approved 1989-90 Plan and Budget, Part IV Procedures, any transfer of funds between Program Budgets shall be accomplished by a Budget Modification in accordance with Section 5(g) of Chapter 138. This Modification would modify the plan to provide for the transfer of \$500,000 from the Oil and Gas Production Program to the Water Injection Program. These funds are needed to complete anticipated injection well work through June 30, 1990. The total adjusted budget would remain unchanged at \$141,377,000.

The State Lands Commission's Executive Officer and Long Beach City Manager mutually agreed to approve the Fifth Modification on May 9, 1990 under the provisions of Section 5(g), Chapter 138 and the Modification is being brought before the Commission for ratification.

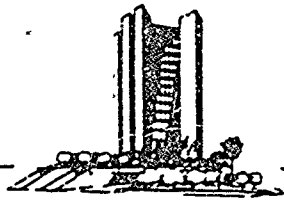

In accordance with the provisions of Part IV, Section A, of the 1989-1990 Plan and Budget, we are submitting for your approval the Fifth Modification of the Plan of Development and Operations and Budget of the Long Beach Unit covering the period July 1, 1989 through June 30, 1990.

The proposed Fifth Modification transfers \$500,000 from the Oil and Gas Production Program to the Water Injection Program. These funds are necessary for anticipated injection well work through June 30, 1990.


