
- A Mitigated Project, Negative Declaration was prepared and adopted for this project on June 6, 1990 by the Reclamation Board. The State Lands Commission's staff has reviewed such document.
- The Reclamation Board (Applicant) has scheduled levee stabilization work at various locations in Sutter, Yolo, and Sacramento counties. At the latter location, in the City of Sacramento, along the Sacramento River, the Applicant will modify the levee to prevent seepage and levee deterioration within a two-mile stretch, from the Captain's Table at the north, south to the projection of Clipper Way and 43rd Avenue. Midway along the two-mile stretch is an approximate 1.3-acre parcel of State land which extends between the present river bank and the existing levee. The Applicant wishes to use a portion of the parcel as a staging area for the cited project. The area to be so used is approximately 0.682 acres.
- 3. The proposed staging area has riparian vegetation at its fringes, but is bare at the center. No riparian vegetation is to be disturbed or removed. The Applicant will use the center area for vehicles and equipment and will vacate the site after the adjacent levee repair work is completed.
- 4. The staff has proposed, and the applicant has accepted, a number of special conditions which will attach to the proposed general permit. These conditions are listed in Exhibit D, attached hereto.



EXHIBIT D

SPECIAL CONDITIONS

- 1. The site shall not be used for staging or construction activities associated with the Sacramento Urban Area Levee Reconstruction Project after November 15, 1990. All vehicles, equipment and material shall be removed from the site as soon as possible after this date, but in no case later than thirty (30) days thereafter.
- 2. At least fifteen (15) days prior to the use of the DaRosa staging area, staff of the Reclamation Board shall submit to the staff of the State Lands Commission, for their review, a contingency plan for responding to the spill of any hazardous material or petroleum product used on site.
- 3. At least fifteen (15) days prior to the use of the DaRosa staging area, staff of the Reclamation Board shall submit to the staff of the State Lands Commission, for their review, the revised contractor bid specifications which specifications shall govern the contractor's activities on said area.
- 4. By June 14, 1990, the staff of the Reclamation Board shall amend the current specifications of the bid package to include guidelines and specifications, developed in cooperation with the staff of the Commission, which will govern the development, by each proposed bidder, of the plot plan of the proposed staging area. Such guidelines may address, among other factors: the location of mobile and stationary equipment, material storage areas, fencing, grading, the location and composition of any retaining berm, the source and composition of any fill material, provisions for lighting, water supply, and a site access plan.
- 5. By July 15, 1990, staff of the Reclamation Board shall submit to the staff of the State Lands Commission, for their review and approval, a site restoration, enhancement, and monitoring plan, incorporating the following elements:
 - A. removal of the existing building on site,
 - B. removal of asphalt,
 - C. revegetation of the site according to a revegetation, enhancement, and monitoring plan to be developed in coordination with staff of the Commission and the U.S. Army Corps of Engineers and implemented pursuant to the Monitoring Plan for Riparian and Wetland Mitigation as specified in the Negative Declaration adopted by the Reclamation Board for the Project, and
 - D. construction of a gate to prevent vehicular access to the site.

The provisions of this condition shall be fulfilled by the Reclamation Board even in the event that the site is not used, as authorized, as a staging area for the proposed project.

- 6. No riparian vegetation shall be removed from the State's parcel.
- 7. No rights shall be exercised or obligations established under this permit until the provisions of Special Condition 4 are met, specifically, the guidelines and specifications have been accepted by the Contracting Officer of the U.S. Army Corps of Engineers.
