RENEWAL OF NON-COMMERCIAL LEASE

APPLICANT: Elkhorn Boat Club, Inc.
c/o Fred Brown
P. O. Box 660935
Sacramento, California 95866

AREA, TYPE LAND AND LOCATION:
A 0.193-acre parcel of tide and submerged land
located in the Sacramento River, Yolo County.

LAND USE: Recreational floating dock and ramp.

TERMS OF PRESENT LEASE:

Initial period: Fifteen (15) years beginning
July 1, 1975.

Renewal options: One successive period of ten
years each.

Surety bond: \$2,000.

Public liability insurance: Combined single
limit coverage of \$300,000.

Consideration: \$366.78 per annum; five-year
rent review.

TERMS OF PROPOSED LEASE RENEWAL:

Initial period: Ten (10) years beginning
July 1, 1990.

Surety bond: \$2,000.

Public liability insurance: Combined single
limit coverage of \$1,000,000.

CONSIDERATION: \$916.36 per annum; with the State reserving the
right to fix a different rental on each
fifth anniversary of the lease.

OTHER PERTINENT INFORMATION:

1. This lease was originally authorized under Minute Item No. 41, July 22, 1976. The original land area, 0.527 acre, was reduced to 0.193 acre, following flood losses and the rent was modified to \$336.28 per annum, effective July 1, 1985.
2. The current application is for a renewal covering the present dock, ramp, and pilings.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities, 2 Cal. Code Regs 2905(a)(2).

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 1, EXISTING FACILITIES, 2 CAL. CODE REGS. 2905(a)(2).
2. AUTHORIZE ISSUANCE TO ELKHORN BOAT CLUB, INC. OF A TEN-YEAR RENEWAL OF LEASE PRC 5166, BEGINNING JULY 1, 1990; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$916.36, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE; PROVISION OF A \$2,000 SURETY BOND; PROVISION OF PUBLIC LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$1,000,000; FOR THE CONTINUED USE OF A DOCK, PILINGS, AND RAMP ON THE LAND DESCRIBED IN SAID LEASE.

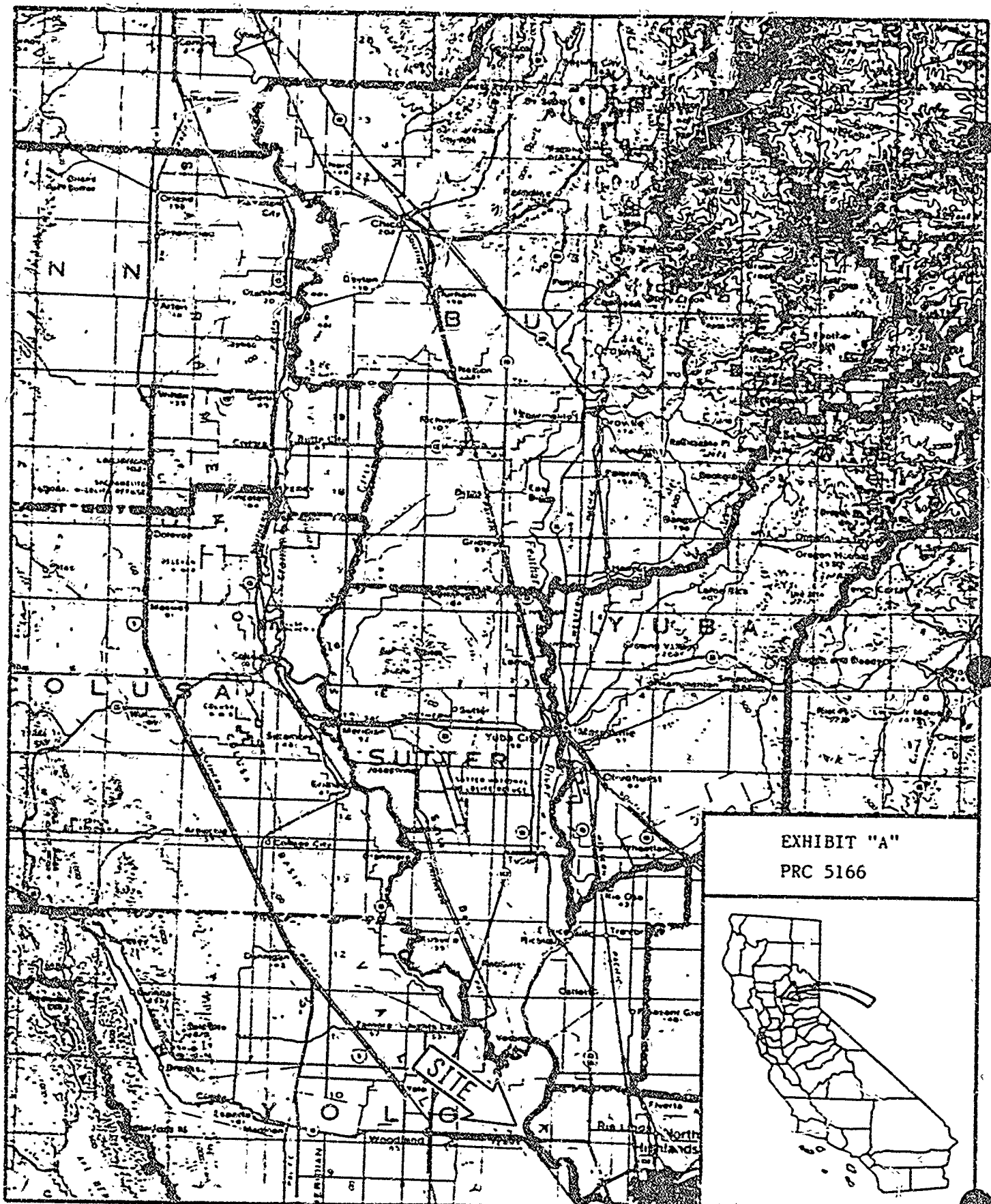
