MAINTENANCE DREDGING PERMIT

APPLICANT: City of Morro Bay
595 Harbor Street
Morro Bay, California 93442

AREA, TYPE OF LAND AND LOCATION:
Granted (minerals reserved) tide and submerged
lands, located in Morro Bay Harbor, San Luis
Obispo County.

PROPOSED LANDS USE:

Dredge a maximum 400,000 cubic yards of
material from the entrance channel and Navy
channel of Morro Bay Harbor to maintain a
navigable depth. The dredged material will be
disposed of immediately offshore of Morro Bay
State Park 8,000 feet south of the entrance to
Morro Bay Harbor and immediately offshore at a
site 8,000 feet north of the entrance to Morro
Bay Harbor between the PG&E and Navy Subsea
pipelines.

TERMS OF THE PROPOSAL PERMIT:

Period: One year commencing
September 1, 1990.

Royalty: No royalty for spoils, placed
at the approved offshore
disposal sites by a public
agency for public benefit.

\$0.25 per cubic yard for
material used for private
benefit or sold.

OTHER PERTINENT INFORMATION:

1. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et. seq. Based upon staff's consultation with the persons nominating such lands and through the CEQA review process it is staff's opinion that the project, as proposed, is consistent with its use classification.
2. A Finding of No Significant Impact (FONSI) was prepared and adopted for this project by the United States Army Corps of Engineers. The document was circulated for public review as broadly as State and local law may require and notice was given meeting the standards in 14 Cal. Code Regs. 15072(a). Therefore, pursuant to 14 Cal. Code Regs. 15225, the staff recommends the use of the FONSI in place of a Negative Declaration.

APPROVALS OBTAINED:

California Coastal Commission, California Regional Water Quality Control Board, California Department of Parks and Recreation, San Luis Obispo County.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE FINDING OF NO SIGNIFICANT IMPACT (FONSI) PREPARED AND ADOPTED FOR THIS PROJECT BY THE UNITED STATES ARMY CORPS OF ENGINEERS MEETS THE REQUIREMENTS OF THE CEQA

AND ADOPT, PURSUANT TO 14 CAL. CODE REGS. 15225, SUCH FEDERAL DOCUMENT FOR USE IN THE PLACE OF THE NEGATIVE DECLARATION.

2. DETERMINE THAT THE PROJECT, AS APPROVED, WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
3. AUTHORIZE STAFF TO ISSUE TO THE CITY OF MORRO BAY, THE DREDGING PERMIT ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION. SAID PERMIT SHALL BE EFFECTIVE FOR A PERIOD OF ONE YEAR BEGINNING SEPTEMBER 1, 1990 AND WILL ALLOW DREDGING A MAXIMUM VOLUME OF 400,000 CUBIC YARDS OF MATERIAL FOR THE PURPOSE OF MAINTAINING NAVIGABLE DEPTHS WITH SPOILS TO BE PLACED AT TWO APPROVED OFFSHORE DISPOSAL SITES. NO ROYALTY SHALL BE CHARGED FOR SPOILS DEPOSITED AS APPROVED BECAUSE THE PROJECT IS FOR THE PUBLIC BENEFIT WITH OFFSHORE DISPOSAL. SUCH ACTIVITY IS CONTINGENT UPON APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS OR LIMITATIONS ISSUED BY FEDERAL, STATE AND LOCAL GOVERNMENT AGENCIES.

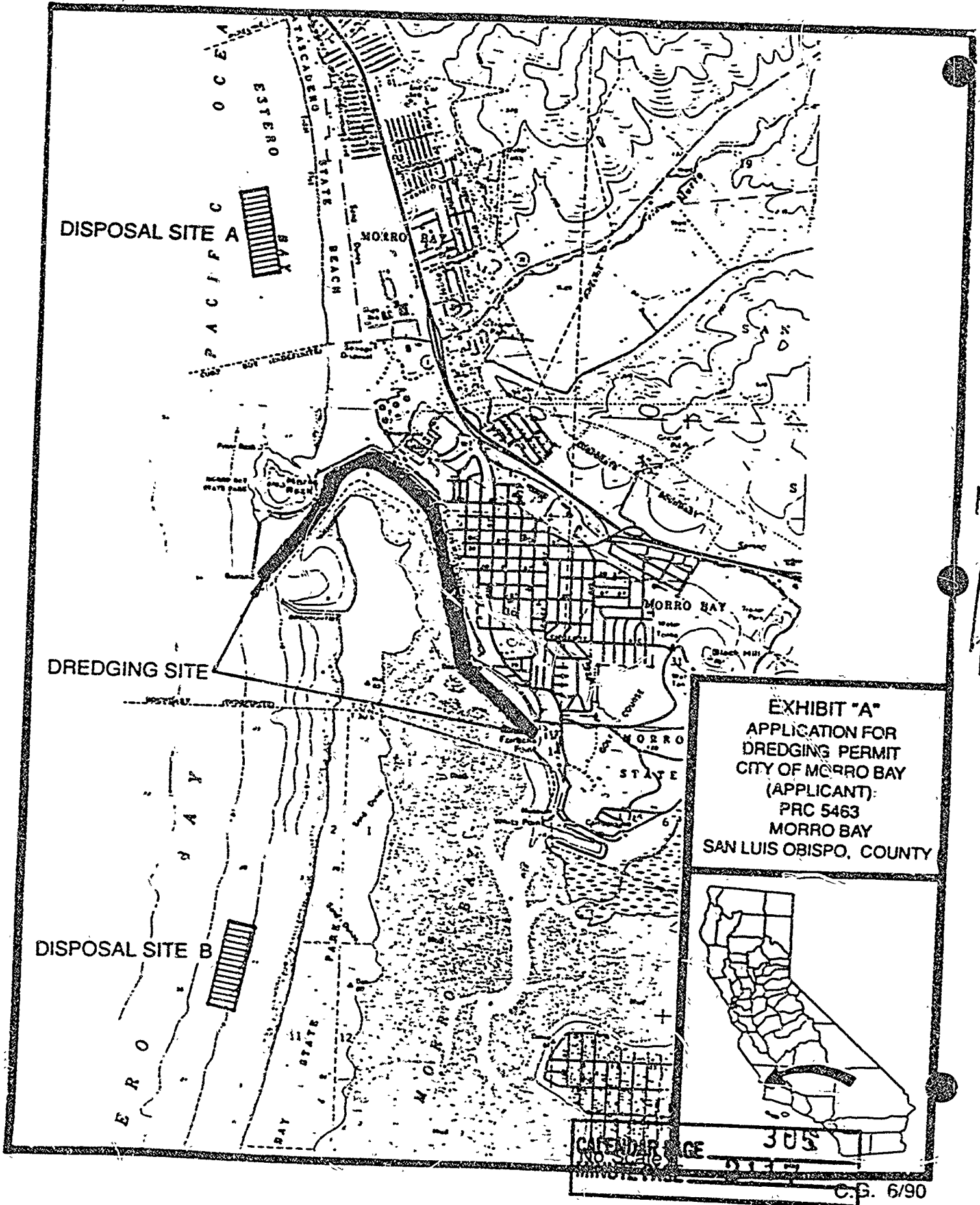


EXHIBIT "A"
