**GENERAL LEASE - RESIDENTIAL USE**

**APPLICANT:**

Sheldon Jones and Donna Weekley  
20 Sandy Beach Road  
Vallejo, California 94590

**AREA, TYPE LAND AND LOCATION:**

A 0.10-acre parcel of tide and submerged land located in  
Mare Island Strait, city of Vallejo, Solano County,  
including privately owned lands subject to the State's  
public trust easement and State-owned sovereign lands.

**LAND USE:**

Use and maintenance of a residence with a deck and boat  
ramp.

**BACKGROUND**

On April 1, 1868, the State issued Tideland Survey numbers 10 and  
11, Solano County. In ensuing years, without boundaries being  
exactly known, the patented area was subdivided into numerous  
small lots, which were developed with homes built upon pilings.

The boundaries of the Tideland Surveys were litigated by private  
land owners in November 1945. The State was not a party to the  
suit. The court described the waterward boundaries of the  
tideland lots at the ordinary low water mark. The State Lands  
Commission surveyed the private judgment line in 1955. It was  
found that many of the porches, decks and small portions of some  
residences encroached below the adjudicated low water line.

Several property owners at Sandy Beach whose structures  
encroached below the adjudicated low water line onto State-owned  
lands have current Commission leases. Staff has notified those  
homeowners who are trespassing on State lands that they must

acquire leases or remove their structures from State lands. It is staff's position, supported by advice from the staff of the Attorney General, that residential use is not consistent with the public trust under which the Commission holds State-owned sovereign lands, and should be permitted at Sandy Beach only to the extent it now exists, for so long as the State's lands are not needed for true public trust purposes.

Sheldon Jones and Donna Weekley have applied to the Commission for a lease of State-owned lands occupied by the existing improvements located at 20 Sandy Beach Road. The proposed lease premises include patented tidelands, subject to the State's public trust easement, upon which the existing residence and a portion of the deck are located, and the area waterward of the adjudicated low water line which is occupied by the remainder of the house and deck structure along with ramp and dock. Rental is charged only for the residence and deck waterward of the adjudicated low water line approximately 0.03 acre. The boat ramp is rent-free pursuant to Section 6305 of the P.R.C. The recommended term is 20 years. The proposed lease contains specific provisions prohibiting expansion of the existing structures, and requiring removal of residential structures from the State's lands under specific circumstances. Because the structure to be authorized by the proposed lease constitutes a relatively minor encroachment below the adjudicated low water line and does not appear to constitute a nuisance, staff recommends issuance of the proposed lease subject to the conditions contained therein, including, but not limited to, the specific provisions referenced above.

**TERMS OF PROPOSED LEASE:**

**Initial period:**

Twenty (20) years beginning February 14, 1991, without right to renewal or extension.

**Surety bond:**

\$2,000.

**Public liability insurance:**

Combined single limit coverage of \$100,000.

**CONSIDERATION:**

\$325 per annum; with the State reserving the right to fix a different rental on each fifth anniversary of the permit.

**BASIS FOR CONSIDERATION:**

Pursuant to 2 Cal. Code Regs. 2003.

**APPLICANT STATUS:**

Applicant is owner of upland.

**PREREQUISITE CONDITIONS, FEES AND EXPENSES:**

Filing fee has been received.

**OTHER PERTINENT INFORMATION:**

1. The existing residence was constructed prior to April 5, 1973, and thus is exempt from the California Environmental Quality Act (CEQA) as an ongoing project, as set forth in the CEQA Guidelines Section 15261. A portion of the existing house, not exceeding 70 square feet, may have been added to the residence after April 5, 1973, but is categorically exempt from CEQA, pursuant to CEQA Guidelines Section 15303, Class 3, New Construction of Small Structures.

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15261 AS AN ONGOING PROJECT, AND AS A CATEGORICALLY EXEMPT PROJECT, CLASS 3, NEW CONSTRUCTION OF SMALL STRUCTURES, 14 CAL. CODE REGS. 15300, 2 CAL. CODE REGS. 2905(c)(2).
2. AUTHORIZE ISSUANCE TO SHELDON JONES AND DONNA WEEKLEY OF A 20-YEAR GENERAL LEASE - RESIDENTIAL USE BEGINNING FEBRUARY 14, 1991; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$325. WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE AND P.R.C. 6503.5; PROVISION OF A \$2,000 SURETY BOND; PROVISION OF PUBLIC LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$100,000; FOR USE AND MAINTENANCE OF A RESIDENCE WITH DECK AND BOAT RAMP, ON THE LAND DESCRIBED ON EXHIBIT "B" ATTACHED AND BY REFERENCE MADE A PART HEREOF.



A parcel of tide and submerged land lying immediately beneath the building and deck on and adjacent to Lot 25 as shown on the James and Waters map of Sandy Beach Cabin Sites, recorded February 14, 1944 in Book 1 of Maps, Pages 1 and 2, in the county Recorders Office of Solano County, California.

EXCEPTING THEREFROM any portion lying landward of the mean high tide line on the W. B. Boggs Survey, per Solano County Superior Court Case Numbers 16949 and 19259.


