REQUEST FOR EXEMPTION FROM COMPETITIVE BID PROCEDURES FOR A SUBSURFACE OIL & GAS LEASE ON COUNTY PROPERTY /SAN JOAQUIN COUNTY

APPLICANT:

County of San Joaquin General Services Department 4520 West Eight Mile Road Stockton, California 95209

AREA, AND TYPE LAND:

A 4.0-acre parcel of county land in portions of Sections 18 and 19, Township 2 South, Range 5 East, MDM, Sam Joaquin County.

BACKGROUND:

The Nahama and Weagant Energy Company has requested San Joaquin County (County) to enter into a subsurface oil and gas lease for certain County-owned lands. Nahama and Weagant Energy Company has leased and has an option to lease acreage surrounding the 4.0-acre parcel of County land. San Joaquin County has requested to be exempted from competitive bidding procedures in order to negotiate a lease with Nahama and Weagant Energy Company which has offered to lease this parcel of land and has agreed to pay San Joaquin County a royalty of 20 percent for any hydrocarbons produced from this lease, and \$50 per-acre, per-year rent, including three years paid in advance and a three-year drilling term. Staff believes that the proposed terms are fair and reasonable.

ETATUTORY AND OTHER REFERENCES: P.R.C. Section 7052 states in part:

"The State Lands Commission may in its discretion exempt particular leases or operating agreements from the procedure required by this section and Section 7053 [competitive bidding procedures] where by reason of the small size of the property or drainage, actual or imminent, such procedure would be in the judgment of the State Lands Commission in the particular cause be impractical."

Staff has reviewed the application of San Joaquin County for a subsurface negotiated oil and gas lease with Nahama and Weagant Energy Company and has determined that it would be impractical for San Joaquin County to follow the competitive public bidding procedures as outlined in Sections 7052 and 7053 of the P.R.C. because the parcel is small in size, the County proposes to develop the surface for other uses so there is no drillsite and the potential for drainage from adjacent lands under lease to Nahama and Weagant Energy Company appears imminent.


