ACCEPT THE DISSOLUTION OF POOLING AND SURRENDER OF STATE OIL AND GAS LEASE PRC 5890 (52.5 ACRES UNDER THE SACRAMENTO RIVER), SACRAMENTO AND YOLO COUNTIES

BACKGROUND:

Negotiated subsurface (no surface use) State oil and gas lease PRC 5890 was issued to Shell Oil Company on August 26, 1980 and was effective on May 20, 1981. The lease contains about 52.5 acres of tide and submerged land in the bed of the Sacramento River in Sacramento and Yolo Counties, California (leased lands). Under the terms of the lease, the lessee is required to pay an annual rental of \$20 per acre (\$1,050 per year for 52.5 acres) and pay 30 percent royalty on all gas removed or sold from the leased lands. Shell Western E&P Inc. is the successor in interest to Shell Oil Company and is the current lessee.

On April 27, 1982, the Commission approved Shell's pooling agreement and all of the leased lands were unitized with other public and private lands to form the "Chilton 1-2 River Unit". On May 3, 1982, directional gas well "Chilton" 1-2 was completed beneath the unitized leased lands and the State received royalty from October 1982 to July 1988.

On September 8, 1988, Shell gave the Commission written notification of its intention to surrender the lease, plug and abandon the "Chilton" 1-2 well and dissolve the "Chilton 1-2 River Unit". However, because of a discrepancy concerning the acreage of the lease and Unit, staff could not, at that time, recommend Commission approval of the surrender until the acreage question was resolved. The acreage question has been received, and payment of adjusted rental and royalty have been received.

CALENDAR ITEM NO. 29 (CONT'D)

P.R.C 6804.1 and Paragraph 6 of the lease permit the lessee to make at any time a written quitclaim or relinquishment of all rights under the lease or of any portion of the leased lands comprising a ten-acre parcel or multiple thereof in a compact form. The quitclaim or relinquishment will be effective when it is filed with the State subject to the continued obligation of the lessee and its surety to pay all accrued rentals and royalties and to abandon all wells drilled on the leased lands. Shell was current with lease rental and the unadjusted royalty at the time of its notification to the State on September 8, 1988.

A review of the Commission's files reveals that no default exists on the lease, that the lessee has complied with all applicable laws and lease provisions, that all rentals and royalties have been paid and that all wells drilled on or into the leased lands have been properly plugged and abandoned.

OTHER PERTINENT INFORMATION:

- 1. Directional gas well "Chilton" 1-2 was drilled on private property, was bottomed beneath the leased lands and was plugged and abandoned in accordance with Commission and Division of Oil and Gas requirements (see Exhibit "D" "Report of Well Abandonment").
- 2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the CEQA Guidelines.

- 3. ACCEPT FROM SHELL WESTERN E&P INC. THE DOCUMENT TITLED "SURRENDER OF OIL AND GAS LEASE" DATED MARCH 28, 1991 (EXHIBIT "F') WHEREIN SHELL SURRENDERS UNTO THE STATE ALL RIGHT, TITLE AND INTEREST IN AND TO THE LEASED LANDS DESCRIBED IN STATE OIL AND GAS LEASE PRC 5890 DATED MAY 20, 1981 AND DESCRIBED ALSO IN THE ATTACHED EXHIBIT "A".
- 4. RELEASE SHELL WESTERN E&P INC. FROM ALL OBLIGATIONS UNDER STATE OIL AND GAS LEASE PRC 5890 AND THE "CHILTON 1-2 RIVER UNIT" EFFECTIVE SEPTEMBER 8, 1988, THE DATE SHELL NOTIFIED THE COMMISSION OF ITS INTENTION TO SURRENDER THE LEASE AND DISSOLVE THE UNIT.
- 5. AUTHORIZE THE EXECUTION OF ANY DOCUMENT NECESSARY TO EFFECT THE COMMISSION'S ACTION.




