BOUNDARY LINE AGREEMENT

PARTY:

Beaver Lumber of Arcata Attn: David McCartney 1220 - 5th Street Arcata, California 95521

AREA, TYPE LAND AND LOCATION:

Establish by agreement a fixed boundary between private uplands and the State's sovereign land in Butcher Slough near the Arcata Marsh in the City of Arcata, County of Humboldt.

LAND USE:

Settlement of a disputed boundary.

BACKGROUND:

A dispute has arisen between the State and private parties over the location of the boundary separating the State's sovereign tide and submerged lands in Butcher Slough and the private uplands. This area has been artificially affected by activities of man in the form of levees and other modifications of the upland property along the existing alignment of historically tidal Butcher Slough.

CURRENT SITUATION:

Private parties have requested that the Commission enter into a Boundary Line Agreement to establish a fixed boundary between the sovereign lands of the State and the private uplands. Such a Boundary Line Agreement would be in settlement of a Quiet Title Action to remove any sovereign claims to the private upland.

APPLICANT STATUS:

Applicant is owner of upland.

AUTHORIZE THE STAFF OF THE STATE LANDS COMMISSION AND THE OFFICE OF THE ATTORNEY GENERAL TO TAKE ALL STEPS NECESSARY TO IMPLEMENT THE TERMS AND PROVISIONS OF THE BOUNDARY LINE AGREEMENT AS ON FILE WITH THE COMMISSION, INCLUDING BUT NOT LIMITED TO, EXECUTION AND ACCEPTANCE OF ALL DOCUMENTS, MAPS, TITLE AND ESCROW INSTRUCTIONS, AND APPEARANCES IN ANY LEGAL PROCEEDINGS BROUGHT CONCERNING THE ABOVE AGREEMENT.
