AWARD OF THE ROYALTY OIL SALES CONTRACT STATE OIL AND GAS LEASES PRC 3033 AND PRC 3413 HUNTINGTON BEACH FIELD, ORANGE COUNTY

#### APPLICANT:

Fletcher Oil and Refining Company 24721 South Main Street Carson, California 90745

#### BACKGROUND:

At its meeting on August 12, 1991, the State Lands Commission authorized the sale of royalty oil from State oil and gas leases PRC 3033 and PRC 3413, Huntington Beach Field, Orange County. The State's share of production from these leases is approximately 9,130 barrels per month of 20.7° API gravity crude oil.

Texaco Trading & Transportation, Inc. is presently purchasing this oil and paying the State a bonus of \$0.3619 per barrel above a Base Price defined as the highest price posted for oil of like gravity and quality on the day of delivery in the Huntington Beach Field among the postings Chevron, U.S.A, Mobil Oil Corporation, Union Oil Company of California and Texaco Trading & Transportation Inc. This contract is scheduled to expire on June 1, 1992. Oil from this lease can be taken in kind or returned to the lessee on one hundred eighty days prior written notice.

A Notice Inviting Bids for a new Royalty Oil Sales Contract to run from June 1, 1992 until December 1, 1993 was published in the Orange County Register on September 17, 1991. The bid opening was scheduled for October 3, 1991. Exhibit "A" shows the results of the bidding.

Fiscal and legal reviews of the submitted bid material were done by the State Lands Commission Auditing and Legal units, respectively. Based on the results of these reviews, the highest responsible bidder has been identified and is designated in Exhibit "A".

Staff recommends awarding the new Royalty Oil Sales Contract for State oil and gas leases PRC 3033 and PRC 3413, Huntington Beach
