RENT REVIEW

LESSEE:

Atchison, Topeka and Santa Fe Railroad Company 740 East Carnegie Drive San Bernardino, California 92408-3571

This is an Industrial Lease for a term of 49 years from November 3, 1975, with an existing annual rent of \$7,080.00 covering 2.952 acres of tide and submerged land at Point Richmord, Contra Costa County for an existing railroad freight slip.

The lease set forth provides that the State may adjust the annual rental to a different amount, effective on each fifth anniversary or subsequent anniversary following the fifth anniversary of the lease.

Staff has reviewed the lease in accordance with the Commission's rental regulations (2 Cal. Code Regs. 2003) and is recommending that the Commission approve the change in rent, as proposed. Staff has notified the Lessee of the change in rent as recommended herein within the time limits prescribed under the lease and has afforded the Lessee the opportunity to comment on the proposed change.

1. In 1985, Lessee requested that the annual rent established in 1980 continue for what was anticipated to be a short period during which Lessee planned to sell its upland and abandon the lease premises.

staff recommends that the new rent of \$23,100, based on Fair Market Appraisal, be approved. Lessee is still hopeful of selling the upland within the next few months.
