Knapp as described in that Grant Deed recorded in the office of the County Recorder of Solano County, California, on the 8th day of December, 1972, in Book 1794 of Official Records, page 71, being the terminus of the herein described strip of land. The sidelines of said easement shall be extended or shortened to meet the angle points and property lines.
