BACKGROUND

The Commission acquired this 135±-acre parcel of lieu lands located near the town of Daggett in 1958 from the Bureau of Land Management (BLM). The parcel is presently encumbered with a 115kv powerline right-of-way which was issued by the BLM prior to consummation of the Commission's indemnity selection and a rightof-way lease approved by the Commission in March 1991. The Commission: 1) approved the issuance of a lease for a natural gas pipeline and metering station to Kern River Gas Transmission Company; and 2) approved the issuance, jointly to Mojave Pipeline and Kern River, a lease for a natural gas transmission line.

On August 28, 1991, staff received an application from Meridian Oil, Inc. to purchase the above-described parcel to facilitate construction of a pipeline lateral to a generating station owned by Southern California Edison Company. This lateral would connect with the Mojave/Kern natural gas pipeline which is scheduled to be in service in early February 1992.

OTHER PERTINENT INFORMATION:

1. Staff has determined that the consideration of this proposed sale of school land is exempt from the requirements of the CEQA as a statutorily exempt project. The project is exempt because it involves an action taken pursuant to the School Land Bank Act, P.R.C. 8700, et seq.

Authority: P.R.C. 8710.

- 2. The consideration of \$365,500 will be deposited in the School Land Bank Fund. The proposed action will facilitate the management of school lands for the purpose of generating revenue and carrying out the goal of the School Land Bank Act. The State Lands Commission will be acting as trustee for the School Land Bank Fund pursuant to Division 7.2 of the P.R.C.
- 3. Staff has filed a General Plan for this activity with the Legislature pursuant to P.R.C. 6373.



There is hereby reserved to the grantor, in all the lands described herein, the absolute right of the people to fish thereupon, as provided by Section 25 of Article 1 of the Constitution of the State of California.

Together with any reversionary rights that may exist in the lands encumbered by the A. T. & S. F. Railroad right of way and the National Trails Highway right of way.

GENERAL PLAN

The State Lands Commission (SLC) proposes to sell $135 \pm$ acres of State lieu land to Meridian Oil, Inc.

Meridian Oil, Inc. has applied to the SLC for purchase of land in Section 23, T9N R1E SBM, San Bernardino County for the purpose of constructing a 12" diameter natural gas pipeline connecting to the Mojave Pipeline, approved by SLC on March 1, 1991, located in the extreme southwest corner of the property. The natural gas pipeline would run northerly, and into the southwest corner of the Southern California Edison Coolwater Generating Station. Current use of the land is open space and an existing right of way corridor.
