#### OTHER PERTINENT INFORMATION:

- 1. Staff of the Commission has not determined the extent of the State Lands Commission jurisdiction at Angel Island and both parties have agreed to a non-prejudicial lease for the existing seawall.
- 2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
- 3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land, 14 Cal. Code Regs. 15304. This project was also found to be categorically exempt by San Francisco Bay Conservation and Development Commission (BCDC), a "functionally equivalent agency" under the CEQA.
