**AUTHORIZE PREPARATION AND PROCESSING OF A
STATE PATENT TO BE ISSUED TO ALBERT A. ARNOLD**

APPLICANT:

The Bank of California, N.A., Trustee

The Bank of California, N.A., Trustee, has requested that a State patent be issued for 40 acres, more or less, of State-owned school land in Shasta County. An application for purchase of the parcel (Shasta Land District 3834) was filed by Albert A. Arnold with Surveyor General on September 11, 1902, and a Certificate of Purchase 4234 showing payment made in full was issued on April 23, 1903. The original certificate of purchase is beyond the control of the present owner of the land and an affidavit pursuant to P.R.C. 7729 has been provided. No patent has yet been issued to complete the chain of title on the parcel.

Staff has examined the file and other information submitted by the Bank of California, N.A., Trustee and has concluded that the laws relating to issuance of a patent for the described lands have been complied with, and that the person to be named in the patent (Albert A. Arnold) is entitled to it. The Bank of California, N.A., Trustee, is the successor in interest to Albert A. Arnold.

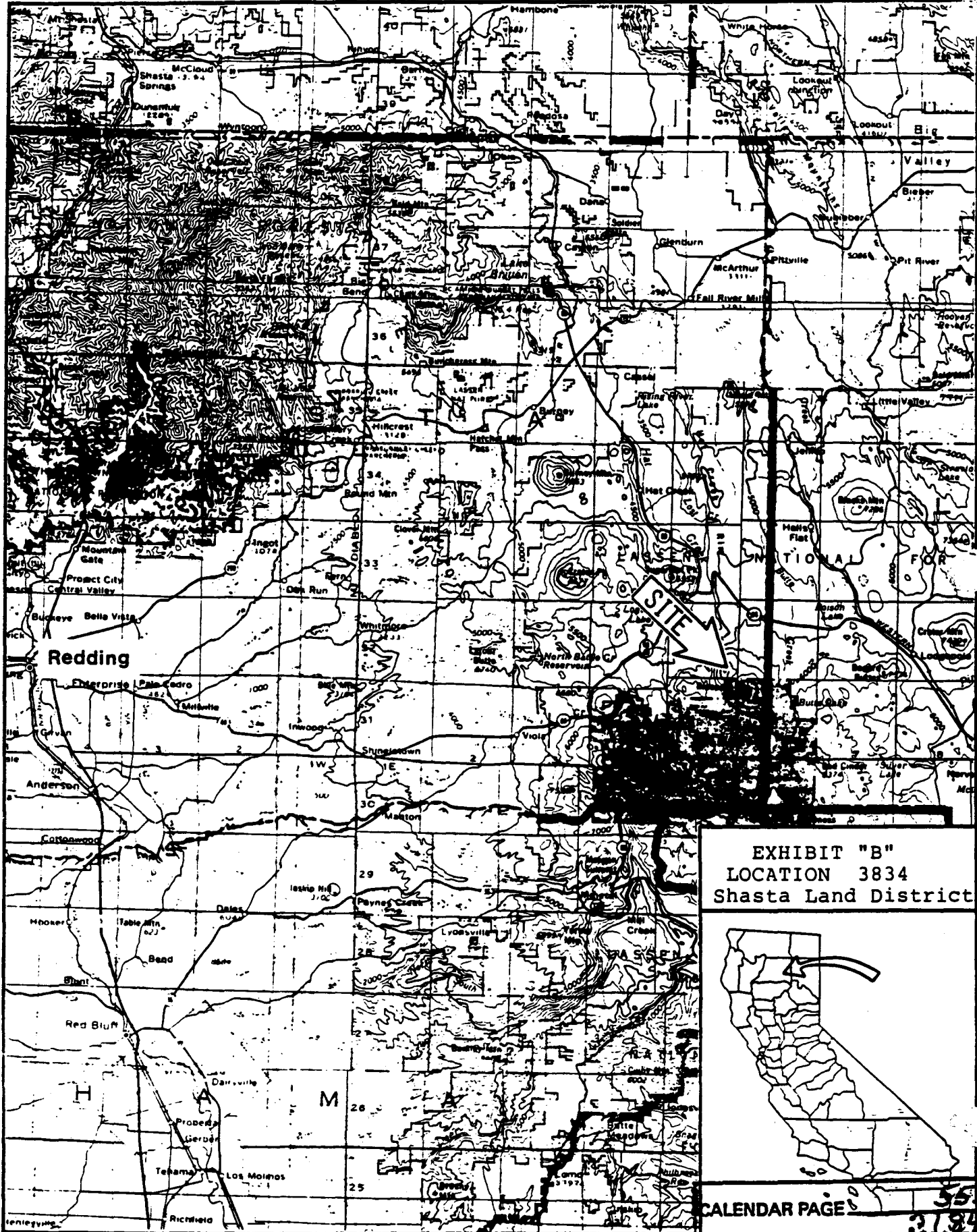
