AMENDMENT TO DREDGING PERMIT PRC 7432

PERMITTEE:

Strawberry Recreation District
301 East Strawberry Drive
Mill Valley, California 94941

AREA, TYPE LAND AND LOCATION:

Granted mineral reservation lands in Richardson Bay, Marin County.

LAND USE:

Dredge a maximum of 35,000 cubic yards of material for the purpose of maintaining a navigable depth of a previously dredged channel. This project is a portion of a larger dredging project consisting of the removal of a total of 200,000 cubic yards, including lands not under Commission jurisdiction. The applicant has proposed disposal of the dredged material at the Corps/EPA-approved Alcatraz Disposal site SF-11.

TERMS OF ORIGINAL PERMIT:

Permit period:

One (1) year beginning November 6, 1991.

Royalty:

No royalty shall be charged for material disposed at the aquatic disposal site, as proposed.

A fee of \$0.25 per cubic yard shall be charged for any material sold or used for commercial or private benefit.

Additional fee:

A fee of \$0.25 per cubic yard for any dredged material disposed of at any site in San Francisco Bay, including, but not limited to, SF-11, to offset the

cost of studies necessary to develop non-bay disposal sites for future use.

TERMS OF PROPOSED AMENDMENT:

Permit period:

Extension of one year beginning November 6, 1992.

Royalty:

No royalty shall be charged for material disposed at the aquatic disposal site, as proposed.

\$0.25 per cubic yard shall be charged for any material sold or used for commercial or private benefit.

Additional fee:

A fee of \$0.25 per cubic yard for any dredged material disposed of at any site in San Francisco Bay, including, but not limited to SF-11, to offset the cost of studies necessary to develop non-bay disposal sites for future use.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:

Filing fee and processing costs have been received.

BACKGROUND:

On November 5, 1991, Minute Item 8, the Commission adopted a proposed Negative Declaration (SCH #90030298) and approved a one-year dredging permit to the Strawberry Recreation District (District), effective on November 6, 1991, to remove approximately 35,000 cubic yards of material from a previously dredged channel. Due to the fact that the District was required to obtain a permit from the State Lands Commission (SLC) before the Corps of Engineers and the San Francisco Bay Conservation and Development Commission (SFBCDC) would issue their permits, the District was unable to complete their project within the year allowed by the SLC permit because dredging did not begin until the other required permits were obtained. The District has, therefore, requested a one-year extension to the permit to enable

them to complete their project.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15025), the staff prepared a Proposed Negative Declaration identified as EIR ND 508, State Clearinghouse No. 90030298. Such Proposed Negative Declaration was prepared and circulated for public review pursuant to the provisions of CEQA and adopted by the Commission on November 5, 1991. Staff believes that the information and analyses within the adopted Negative Declaration is appropriate for the consideration of the proposed amendment.
2. This amendment authorizes the extension of the previous lease period for one year, beginning November 6, 1992.
3. All other terms and conditions of the permit remain in full force and effect.

APPROVALS OBTAINED:

United States Army Corps of Engineers, SFBCDC, Regional Water Quality Control Board, and County of Marin.

IT IS RECOMMENDED THAT THE COMMISSION:

1. CERTIFY THAT A NEGATIVE DECLARATION, ND 508, STATE CLEARINGHOUSE NO. 90030298, WAS PREPARED AND ADOPTED FOR THIS PROJECT PURUSANT TO THE PROVISIONS OF THE CEQA AND THAT THE COMMISSION HAS AGAIN REVIEWED, AND CONSEIDERED THE INFORMATION CONTAINED THEREIN.

DETERMINE THAT THE PROJECT, AS APPROVED, WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.

2. AUTHORIZE THE AMENDMENT OF LEASE PRC 7432, ISSUED TO THE STRAWBERRY RECREATION DISTRICT, TO EXTEND THE PERMIT TERM ONE YEAR, BEGINNING NOVEMBER 6, 1992, FOR MAINTENANCE DREDGING ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

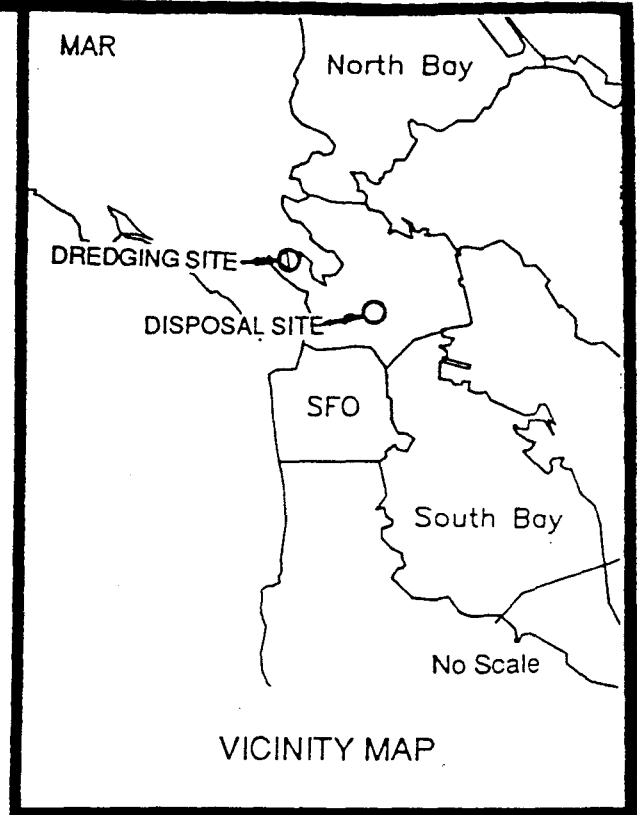
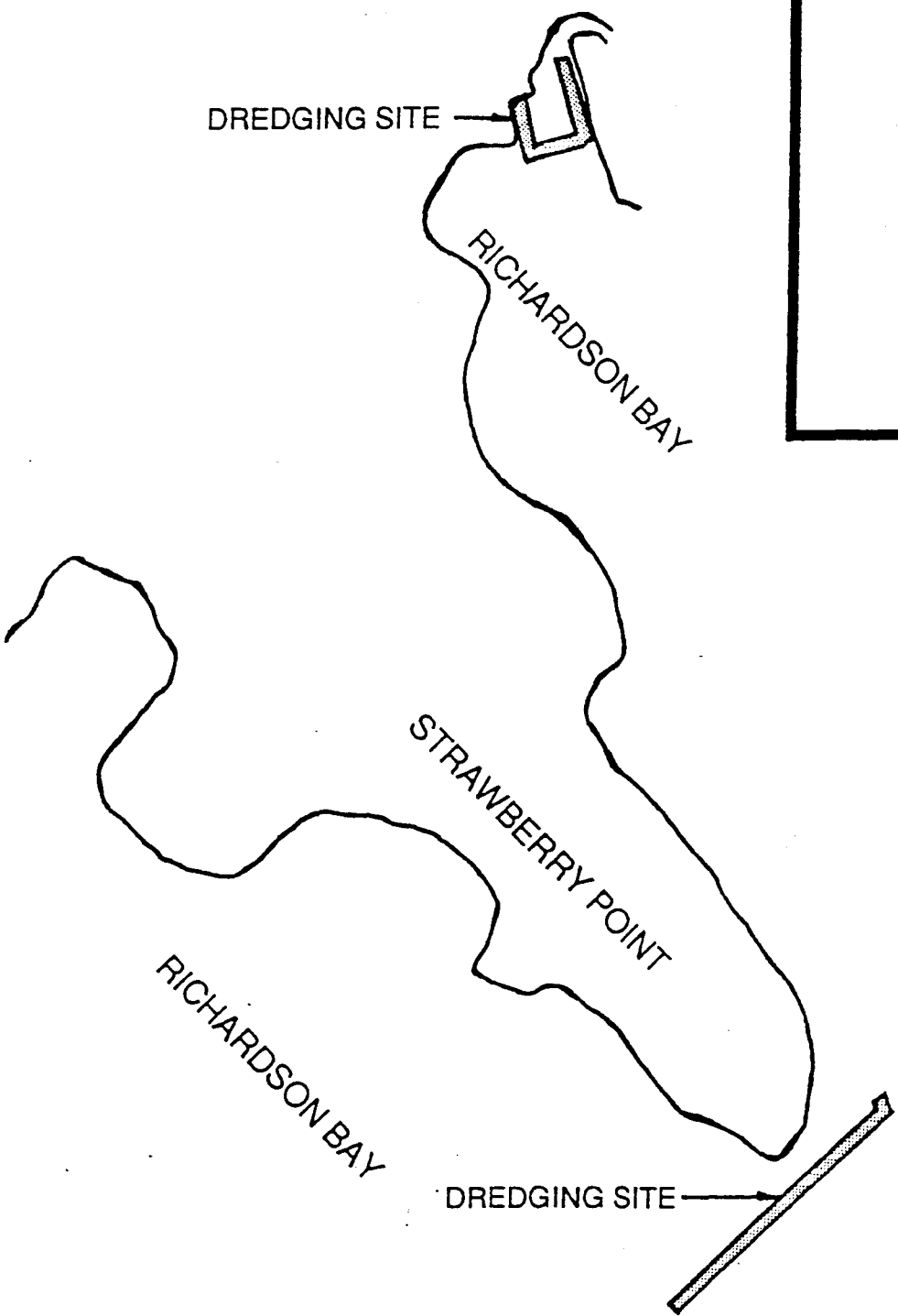
