OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority
and the State CEQA Guidelines (14 Cal. Code

Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a statutorily exempt project. The project is exempt because it involves an action taken pursuant to the School Land Bank Act, P.R.C. 8700, et seq. Authority: P.R.C. 8710.

2. The sale involves land identified by Department of Fish and Game as possessing significant environmental values, Desert Tortoise and Mojave Ground Squirrel, pursuant to P.R.C. 6370, et seq. The property has been surveyed for Desert Tortoise, using U.S. Fish and Wildlife Service methodologies and no Desert Tortoise or tortoise sign was observed. Potential impacts to the State-listed threatened Mojave Ground Squirrel and any other sensitive wildlife species will be determined through the CEQA process.

The Department of Fish and Game has been consulted and does not oppose the sale.

3. The consideration of \$42,840 will be deposited into the School Land Bank Fund to facilitate the management of school lands for the purpose of generating revenue and carrying out the goal of the School Land Bank Fund. The State Lands Commission will be acting as trustee for the School Land Bank Fund pursuant to Division 7.7 of the P.R.C.
3. Staff has filed a General Plan for this activity with the Legislature pursuant to P.R.C. 6373.

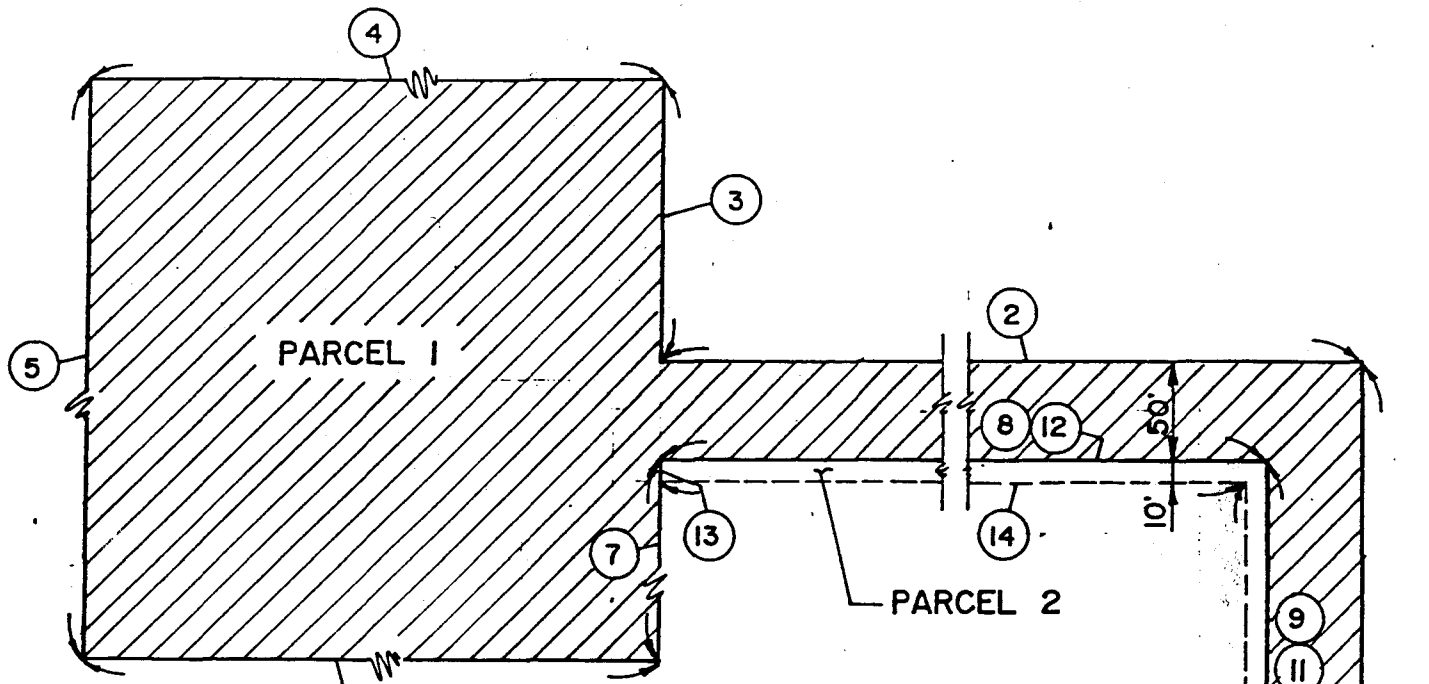

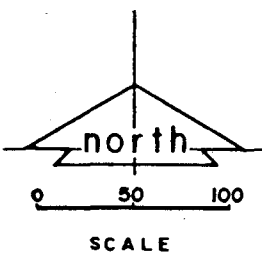
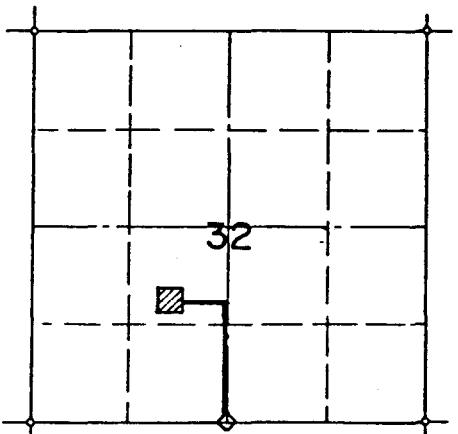

GENERAL PLAN

The State Lands Commission proposes to sell a 6.4 acre parcel of unimproved State School land to the Rosamond Community Services District (RCSD).

The RCSD is acquiring this land for use as a pump station and reservoir site. The project will provide water to a portion of RCSD's Assessment District No. 3 which is currently undeveloped. The pump station and water reservoirs are needed to deliver water to the growing community of Rosamond. The reservoirs will also provide fire flow and emergency storage. A reclaimed water reservoir, to supply water for tract landscaping, is also planned for this site.

Ultimately, two-2.0 million gallon potable water storage reservoirs and one-2.0 million gallon reclaimed water storage reservoirs are planned for above grade construction at this site. The reservoirs will be painted a color to match the surrounding area. The pump station has an ultimate capacity of 3400 gallons per minute and will be housed in a metal building. The pump station and reservoir area will be leveled off to a relatively flat plane. The 50 feet wide strip of land will serve as the access road from Dawn Road (south line of Section 32) to the main portion of land where the pump station and reservoirs will be located. In addition, three below grade pipelines will be constructed along this 50 feet wide strip of land.

RCSD filed a Negative Declaration for the Assessment District No. 3 project in June, 1992, which included discussion for the proposed site improvements. RCSD has been advised by the California Department of Fish and Game that replacement habitat must be obtained for the loss of Mojave Ground Squirrel habitat.

Construction of these facilities is scheduled to begin in early 1993, pending the geotechnical investigation and completion of the environmental work. Construction will last approximately six months.
