**GENERAL LEASE - RIGHT-OF-WAY USE**

**APPLICANT:**

Mobil Oil Corporation  
Attn: Ruth Cronin-Fruitt  
3020 Old Ranch Parkway, Suite 200  
Seal Beach, California 90740-2751

**AREA, TYPE LAND AND LOCATION:**

A 0.48-acre parcel of tide and submerged lands in the Salinas River, five miles northwest of Bradley, Monterey County.

**LAND USE:**

Continued use and maintenance of one 12-inch diameter oil pipeline; one 6-inch diameter natural gas pipeline; one 4-inch diameter cutter stock oil pipeline (all lines existing and constructed of welded steel with corrosion coating and cathodic protection); and one existing overhead telephone line for communication purposes.

**TERMS OF ORIGINAL LEASE:**

Lease period:  
Fifteen (15) years beginning September 28, 1978.

Public liability insurance:  
Combined single limit coverage of \$1,000,000.

**CONSIDERATION:**

\$331 per annum, with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

**TERMS OF PROPOSED LEASE:**

Lease period:

Fifteen (15) years beginning September 28, 1993.

Public liability insurance:

Combined single limit coverage of \$1,000,000.

**CONSIDERATION:**

\$660 per annum, with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

**BASIS FOR CONSIDERATION:**

Pursuant to 2 Cal. Code Regs. 2003.

**APPLICANT STATUS:**

Applicant is permittee of upland.

**PREREQUISITE CONDITIONS, FEES AND EXPENSES:**

Filing fee and processing costs have been received.

**OTHER PERTINENT INFORMATION:**

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, 2905(a)(2).
2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

3. Internal surveys of the existing pipelines are completed every five years - the last survey being completed in July 1992. The staff has reviewed the July 1992 survey and based upon the 1992 survey has determined the existing pipelines to be in good condition. Whenever internal surveys are conducted on the leased premises, copies of those reports will be sent to the Lessor.
4. Lessee should contact the Long Beach office by telephone at (310) 590-5201 (24 hours) and get verbal concurrence for any emergency repairs.
5. All terms and conditions of the existing lease PRC 5538 will remain in full force and effect until its expiration on September 27, 1993.

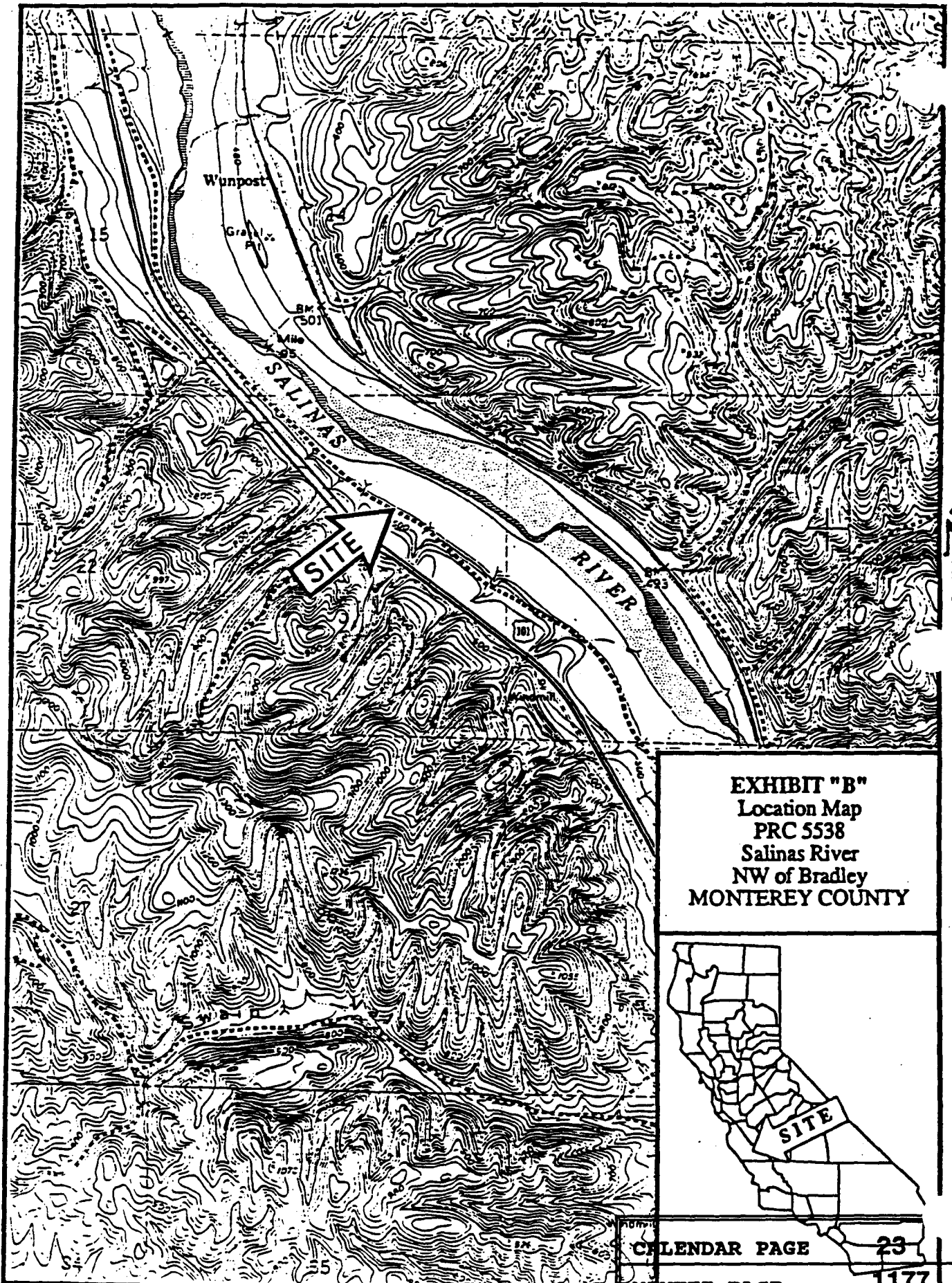
