GENERAL PERMIT - PUBLIC AGENCY USE

AREA, TYPE LAND AND LOCATION:

6.44 acres, tide and submerged lands, Pacific Ocean, at the
City of Oceanside, San Diego County.

PROPOSED PERMIT TERMS:

Permit period:
49 years beginning August 2, 1993.

Consideration:

The public health and safety; with the State reserving
the right at any time to set a monetary rental if the
Commission finds such action to be in the State's best
interest.

BASIS FOR CONSIDERATION:

CALENDAR ITEM NO. C22 (CONT'D)

Staff has reviewed the document and determined that the conditions, as specified in 14 Cal. Code Regs 15253 (b), have been met for the Commission to use the environmental analysis document certified by the Coastal Commission as a Negative Declaration substitute in order to comply with the requirements of CEQA.

2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.
3. The City of Oceanside owns and operates an ocean outfall line to discharge secondary treated effluent from the City's waste water treatment facilities. The line, which is located within legislatively granted lands, was put into service in 1975. The line is underlain by ballast which has shifted, leaving some parts of the facility with inadequate support. The City proposes to place additional ballast at various sections of the line, and it appears that the additional ballast will extend to, and be partially located on, ungranted sovereign lands adjacent to the structure. Other permitting jurisdictions have approved the project and the staff recommends Commission approval thereof. The primary purpose of the ballast is to protect the pipe from the effects of water movement produced from currents, or waves and from lateral movement during a seismic event.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT AN ENVIRONMENTAL ANALYSIS DOCUMENT (CALIFORNIA COASTAL COMMISSION PERMIT #6-93-02) WAS CERTIFIED FOR THIS PROJECT BY THE CALIFORNIA COASTAL COMMISSION UNDER ITS CERTIFIED PROGRAM (14 CAL. CODE REGS. 15251 (c)), AND THAT THE STATE LANDS COMMISSION HAS REVIEWED SUCH DOCUMENT AND THAT THE CONDITIONS AS SPECIFIED IN 14 CAL. CODE REGS. 15253 (b) HAVE BEEN MET.
2. FIND THAT THIS ACTIVITY WILL INVOLVE LANDS IDENTIFIED AS POSSESSING SIGNIFICANT ENVIRONMENTAL VALUES PURSUANT TO P.R.C. 6370, ET SEQ., BUT THAT SUCH ACTIVITY WILL HAVE NO DIRECT OR INDIRECT EFFECT ON SUCH LANDS.
3. AUTHORIZE ISSUANCE TO THE CITY OF OCEANSIDE OF A 49-YEAR GENERAL PERMIT - PUBLIC AGENCY USE BEGINNING AUGUST 1, 1993; IN CONSIDERATION OF THE PUBLIC HEALTH AND SAFETY, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR THE PLACEMENT OF BALLAST MATERIALS ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

LEGAL DESCRIPTION
EXHIBIT "A"

Two parcels of tide and submerged land, each 20.00 feet in width, lying in the Pacific Ocean, in the Gulf of Santa Catalina, vicinity of the City of Oceanside, San Diego County, State of California described as follows:

Parcel 1

A strip of tide and submerged land, 20.00 feet in width, lying southeasterly of, parallel with and adjoining the entire length of course number 3 as described in Sec. 14 of Chapter 846 of the State of California Statutes of 1979.

Parcel 2

A strip of tide and submerged land, 20.00 feet in width, lying northwesterly of, parallel with and adjoining the entire length of course number 5 as described in Sec. 14 of Chapter 846 of the State of California Statutes of 1979.

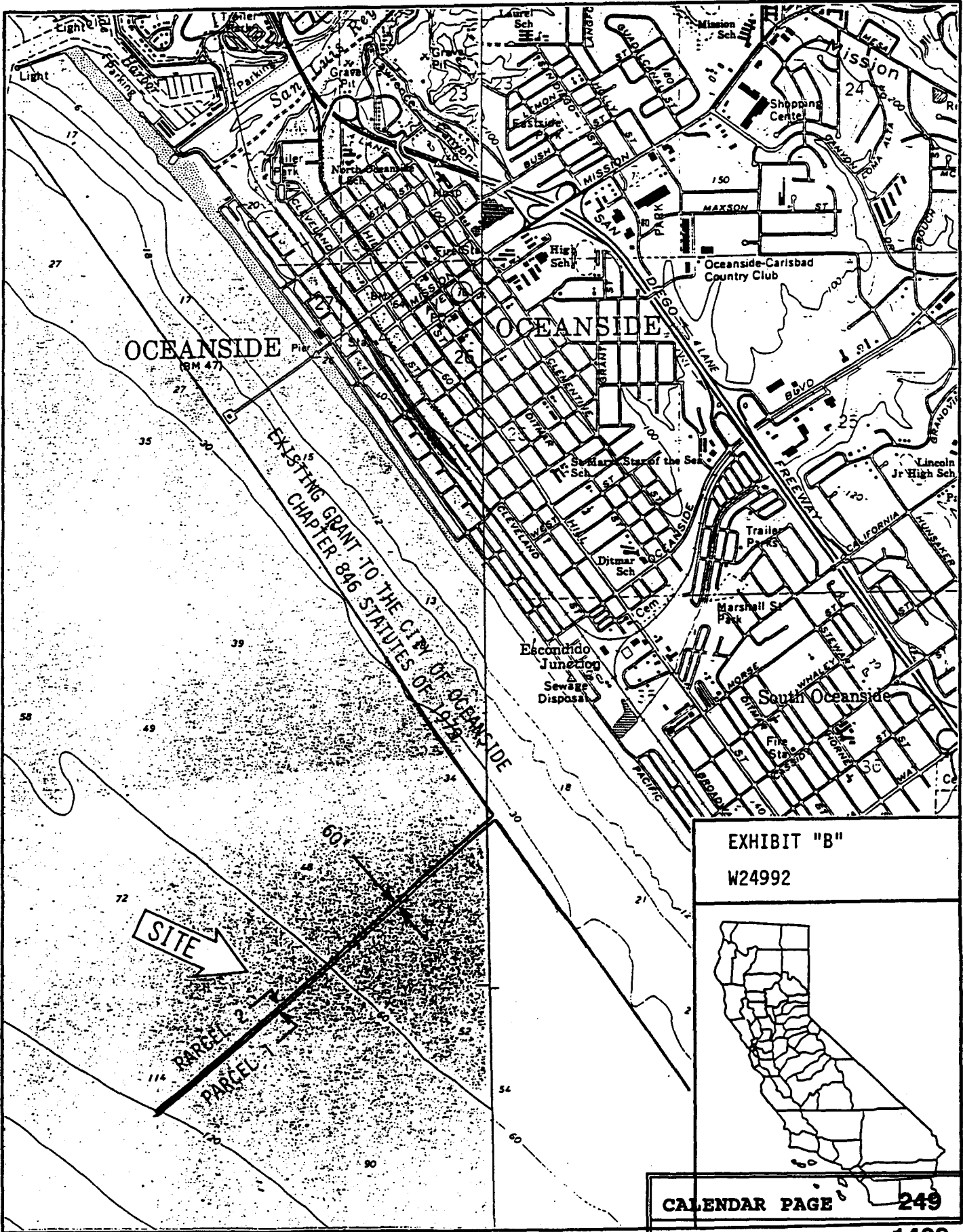
