AUTHORIZE, AS BOTH STATE LANDS COMMISSION
AND SCHOOL LAND BANK TRUSTEE, OFFERING FOR SALE A PARCEL OF
STATE SCHOOL LAND IN SAN BERNARDINO

PARTY:

Pursuant to P.R.C. 8700 (School Land Bank Act) and the School Land Management Study, staff is identifying parcels of land scattered throughout the State that have a possible highest and best use for sale for surface development. Staff has made a preliminary determination that a 640±-acre parcel of State school land in San Bernardino County fits within the above-mentioned criteria.

Staff proposes that the Commission authorize offering the property for sale by competitive bid. The minimum bid will be the appraised value of the parcel; any associated costs incurred in preparing the sale will be collected prior to the issuance of a patent.

Final bids on the property will be presented to the Commission for approval and acceptance.

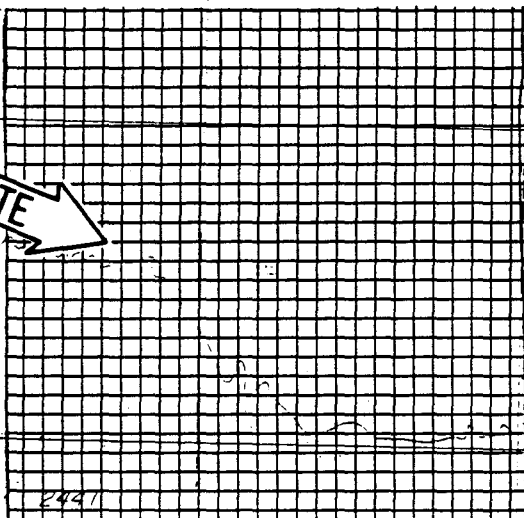

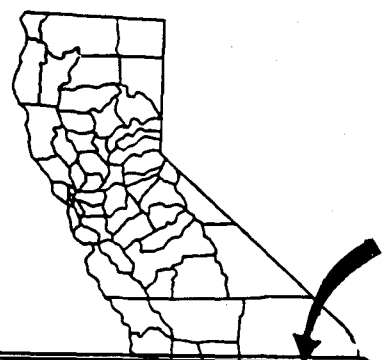
