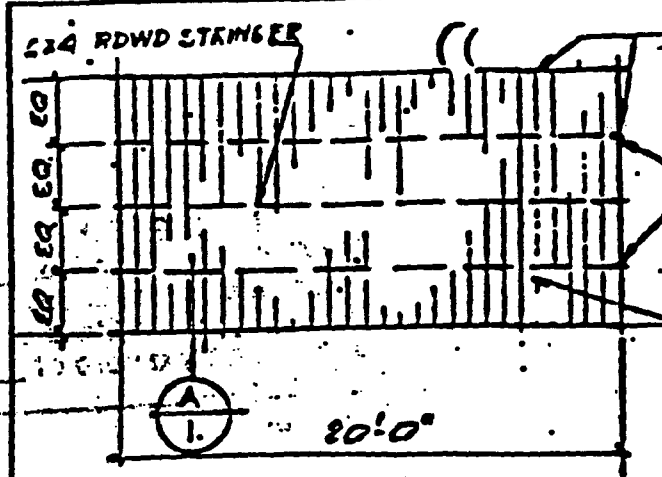

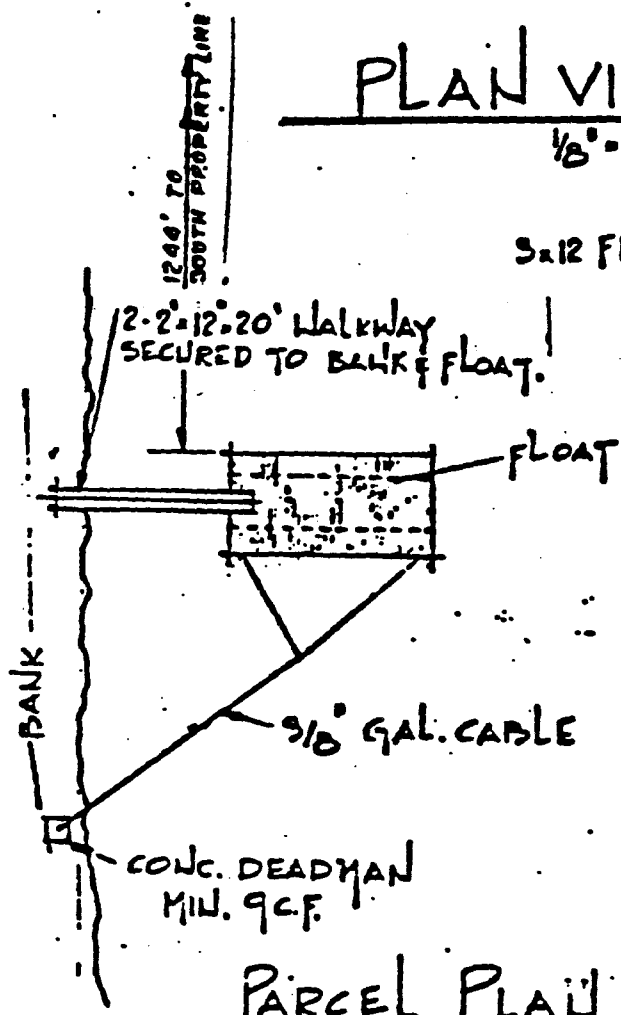

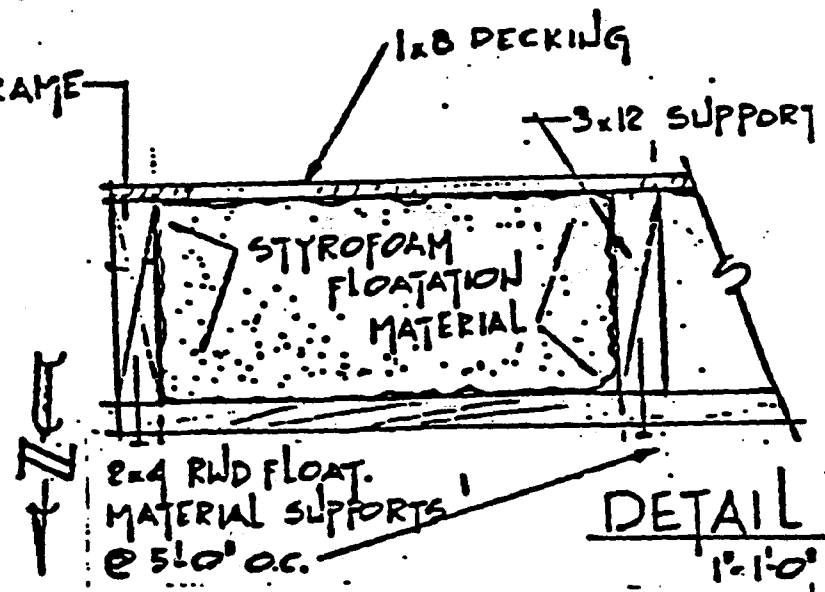


PLAN VIEW

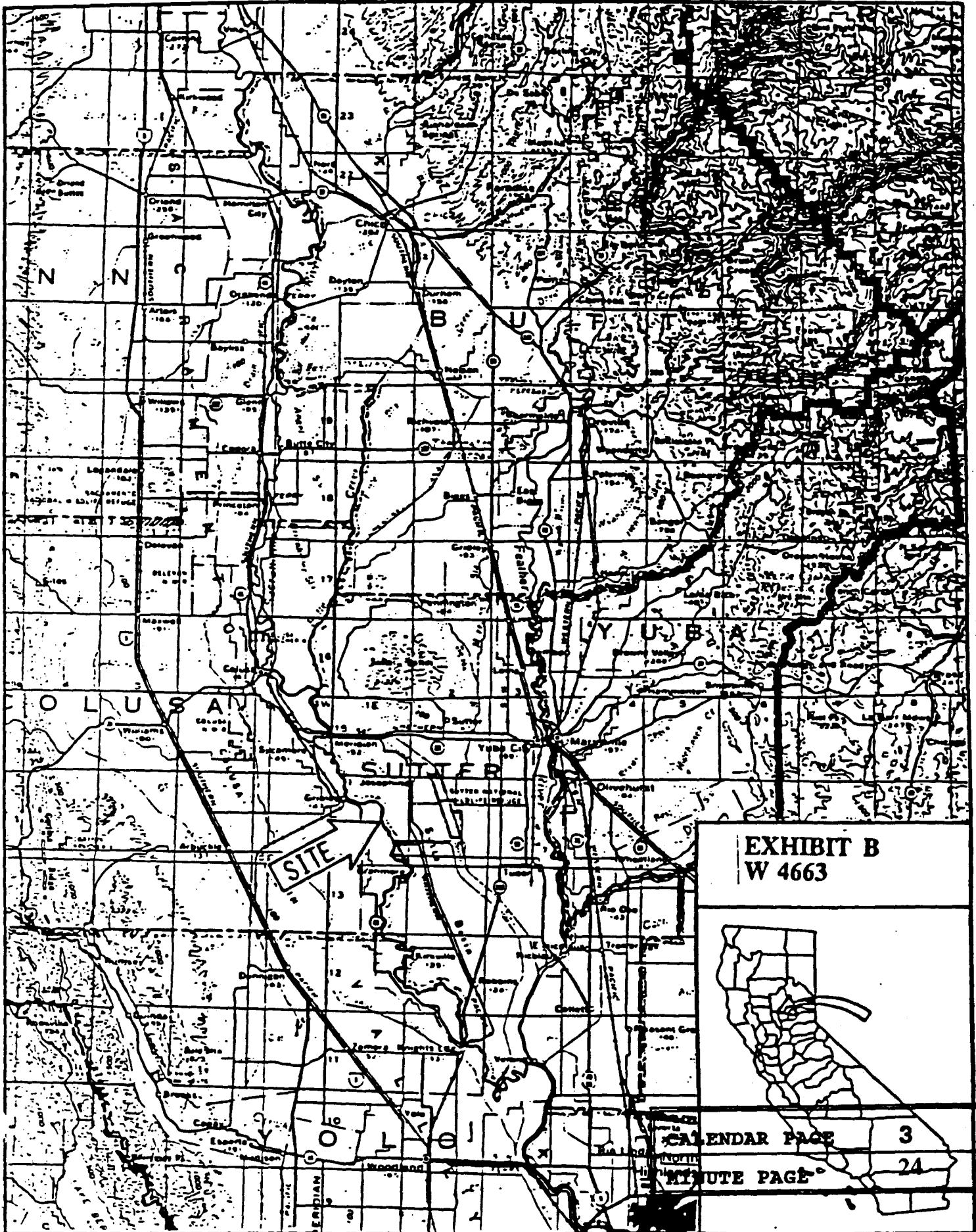
