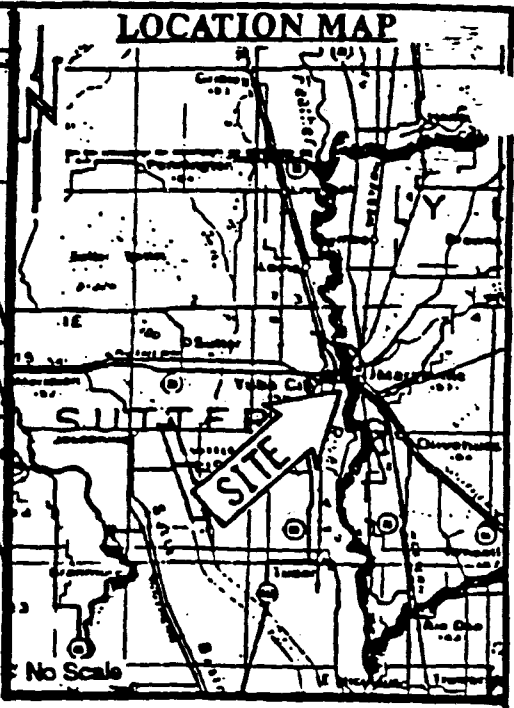
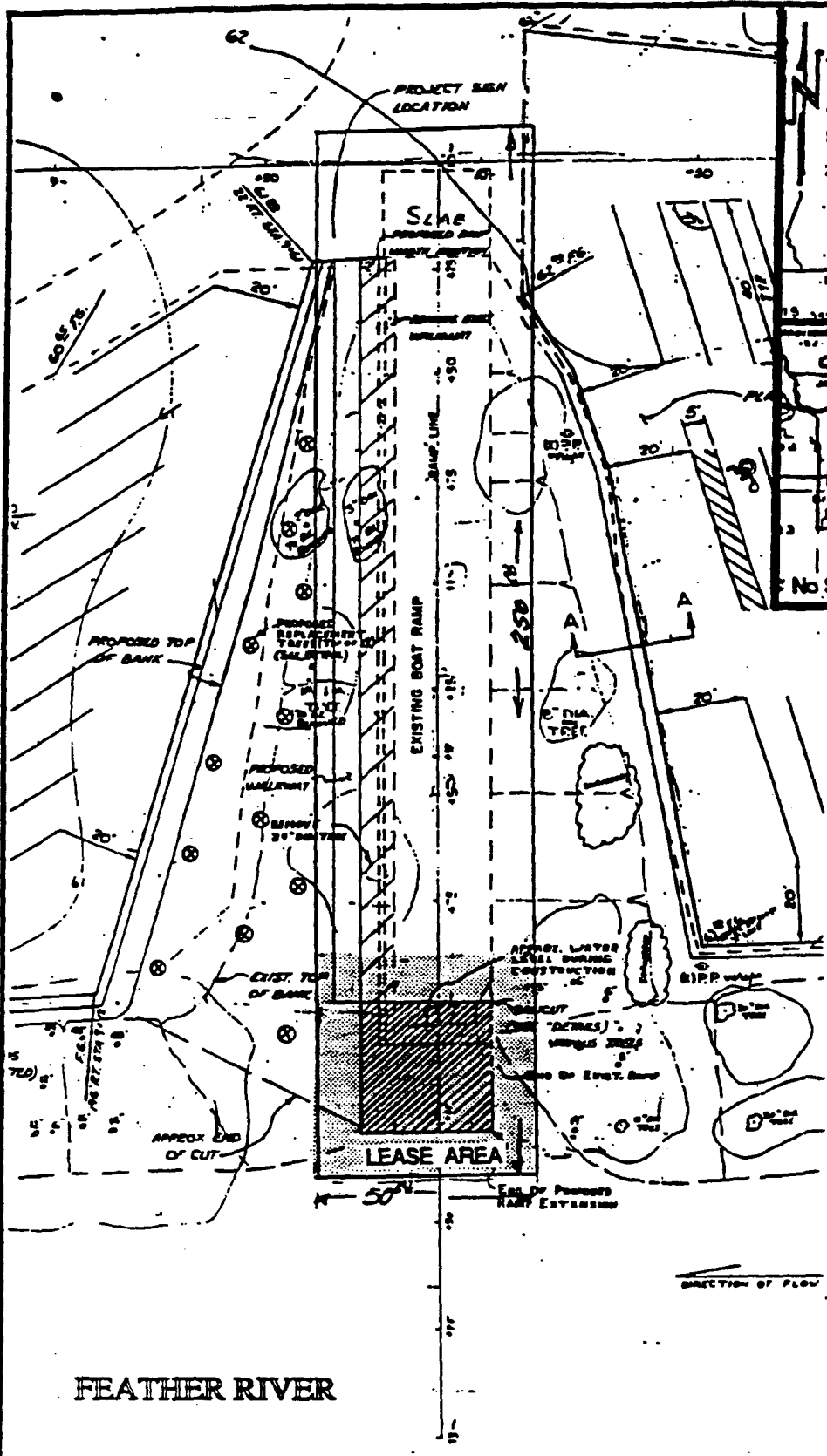

MADE A PART HEREOF.

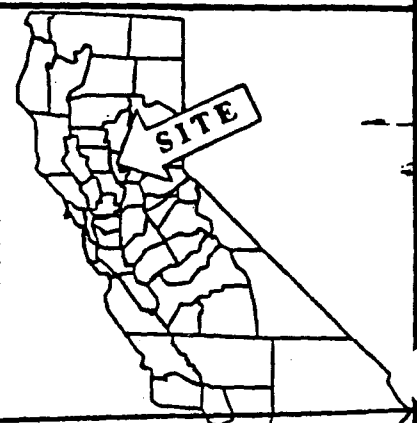
