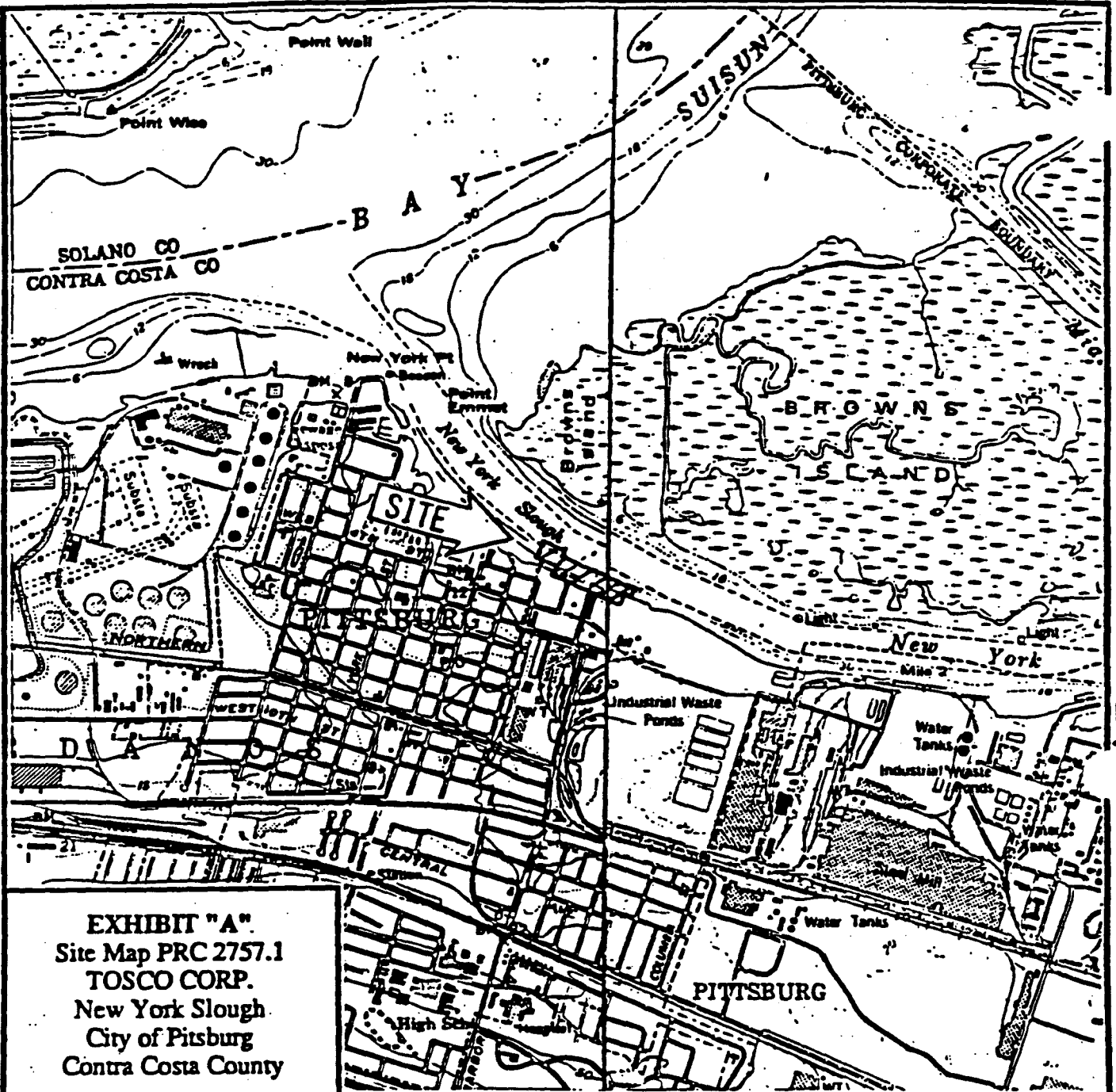
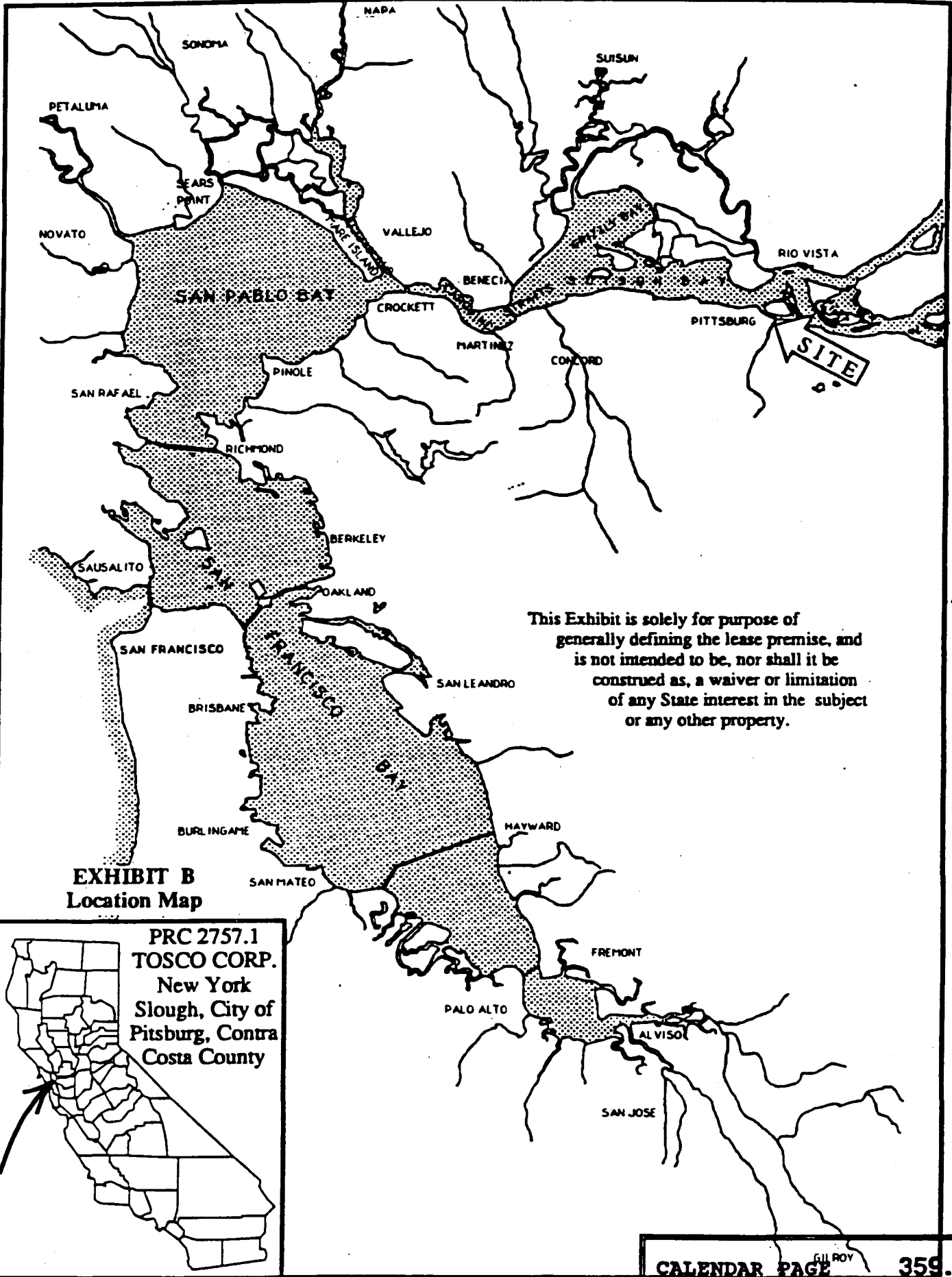


EXHIBIT "A"
