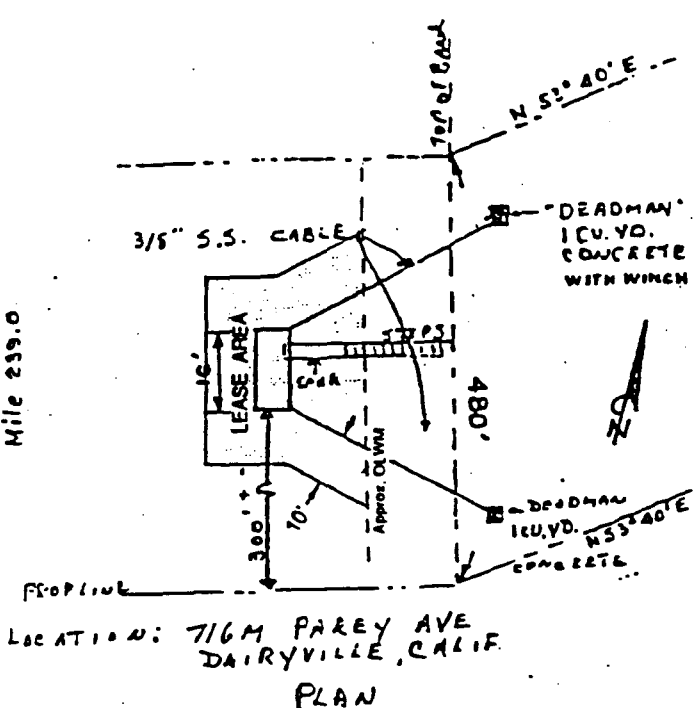

PART HEREOF.

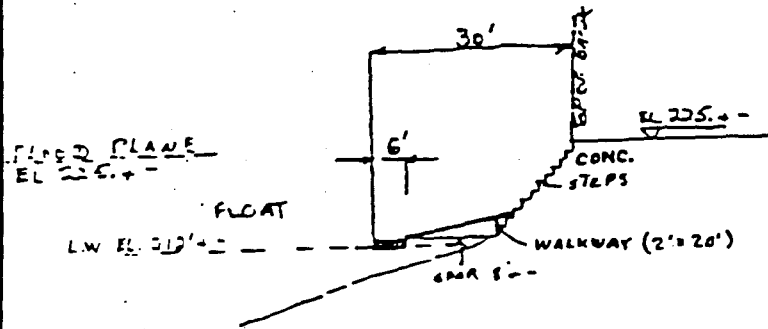
SACRAMENTO RIVER

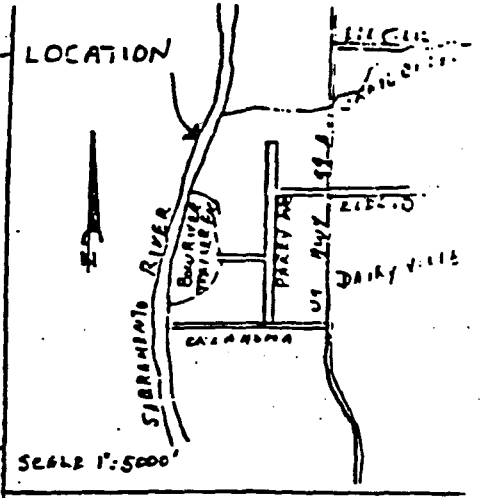


LOCATION: 716M PAREY AVE

PLAN

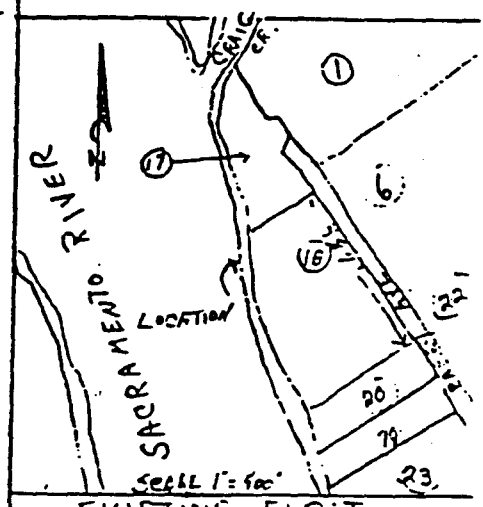


ELEVATION NO SCALE

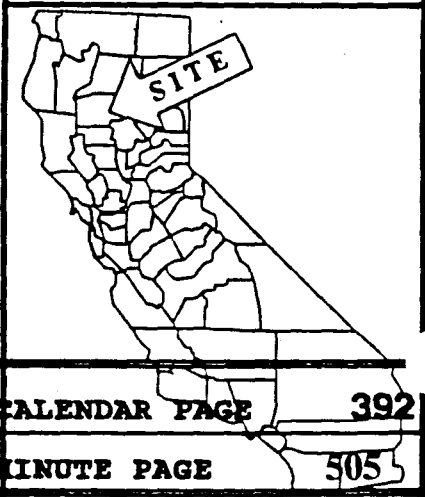
VICINITY MAP
