Negotiated subsurface (no surface use) State oil and gas lease PRC 7714 was entered into with Nahama & Weagant Energy Company (Nahama & Weagant) on September 9, 1993. This lease contains approximately 93 acres in the bed of the Snodgrass Slough located within Sections 2, 3, 10 and 11, T5N, R4E, MDM, Sacramento County, California.

Paragraph 22(b) of the lease allows the Lessee, with the consent of the State and under terms and conditions approved by the State, to pool or unitize all or part of the leased lands with lands held by the Lessee or others.

Nahama & Weagant proposes to form an operating unit that contains a total of 640 acres of State and private leased lands (described in Exhibit "A"). Nahama & Weagant's unit is called the "Herzog 2-1 Unit" and is created for the development and production of natural gas. Nahama and Weagant has requested that the Commission consent to the pooling of 60.10 acres of leased lands under State oil and gas lease PRC 7714 by approving Nahama & Weagant's Declaration of Pooling dated March 23, 1991, which created the "Herzog 2-1 Unit" and the revised pooling map dated April 12, 1993 which includes the State's 60.10 acres representing 9.3906 percent of the pool. The Commission staff has evaluated the geologic and reservoir data and has determined that this unit will be economically advantageous to the State to share in the production from the proposed unit.

WHEREAS, BENTON OIL AND GAS COMPANY, ARKOMA PRODUCTION COMPANY OF CALIFORNIA AND ATLANTIC RICHFIELD COMPANY, hereinafter jointly referred to as the "Declaring Parties", are the present owners and holders of the Lessee's right, title and interest in those certain Oil, Gas and Mineral Lesses (hereinafter referred to as "said lesses") particularly described in Exhibit "A" attached hereto and made a part hereof; and

WHEREAS, the Declaring Parties desire to pool, combine and unitize lands covered by said leases (including all formations of sand, siltstone and shales underlying said lands), for the purpose of exploration, development and production of (hereinafter referred to as "pooled substances"), in accordance with the provisions of said leases and other agreements in connection therewith.

NOW THEREFORE, the Declaring Partias do hereby declara, effective as of the 23rd day of March, 1991, the formation of the gas production pool designated the "Herzog 2-1 Pool" (hereinafter referred to as "said Pool") the exterior boundaries of which are shown on the plat designated Exhibit "B" attached heret, and made a part hereof.

Royalties payable from the pooled substances allocated to the individual leases comprising said Pool shall be determined and paid on a basis prescribed in each of the individual leases. Said Pool shall be developed and operated as a single entity and all pooled substances produced therefrom shall be allocated to each lease comprising said Pool in the proportion that the pooled acreage committed from such lease bears to the total Pool acreage.

While said Pool created hereby is in full force and effect, the Declaring Parties hereby pool, combine and unitize said leases and all gas condensate and other gaseous substances in and under any parcel or parcels within the Pool which are not presently under lease to the Declaring Parties but which any Declaring Party may hereafter lease or which may be included in one or more leases pursuant to Section 3608 of the Public Resource Code of the State of California.

This instrument may be executed in counterparts. Each executed counterpart shall be binding upon the executory party thereto as fully as if all Declaring Parties had executed one instrument, and said Declaring Parties may combine said counterparts to form one single instrument for recording purposes.

IN WITNESS WHEREOF, the Declaring Parties have caused this Declaration to be duly executed as of the 12th day of September, 1991.
