CURRENT LEASES TERMS:

Lease term:

20 years and so long thereafter as producing in paying quantities.

Rent:

\$1.00/acre per annum.

Royalty:

Variable from 12 1/2 percent to 20 percent.

BACKGROUND:

The twenty-seven (27) state oil and gas leases and one (1) drill site agreement that Shell Western E&P, Inc., is requesting to assign to Shell Onshore Ventures, Inc., are all located within the Huntington Beach Offshore Field, Orange County. The leases were issued between the dates of September 26, 1938 and August 17, 1973, and have been assigned a number of times since their issuance.

Shell Western E&P, Inc., (SWEPI), the present lessee, contacted Commission staff on January 3, 1994 and requested Commission approval of the assignment of these leases to Shell Onshore Ventures, Inc., via Shell Oil and Gas Investment, Limited Partnership. The reason SWEPI has requested this assignment is to restructure their investments as a means to attract additional investment capital for all their offshore properties.

Since SWEPI will continue to operate all properties for Shell Onshore Ventures, Inc., there will not be a change in the operator for the leases and drill site agreement. SWEPI will remain responsible for all lease operations and responsibilities including well abandonments and oil spill containment.

Applicant is lessee of upland.

- 4. THIS ASSIGNMENT WILL BE EFFECTIVE ON APRIL 1, 1994.

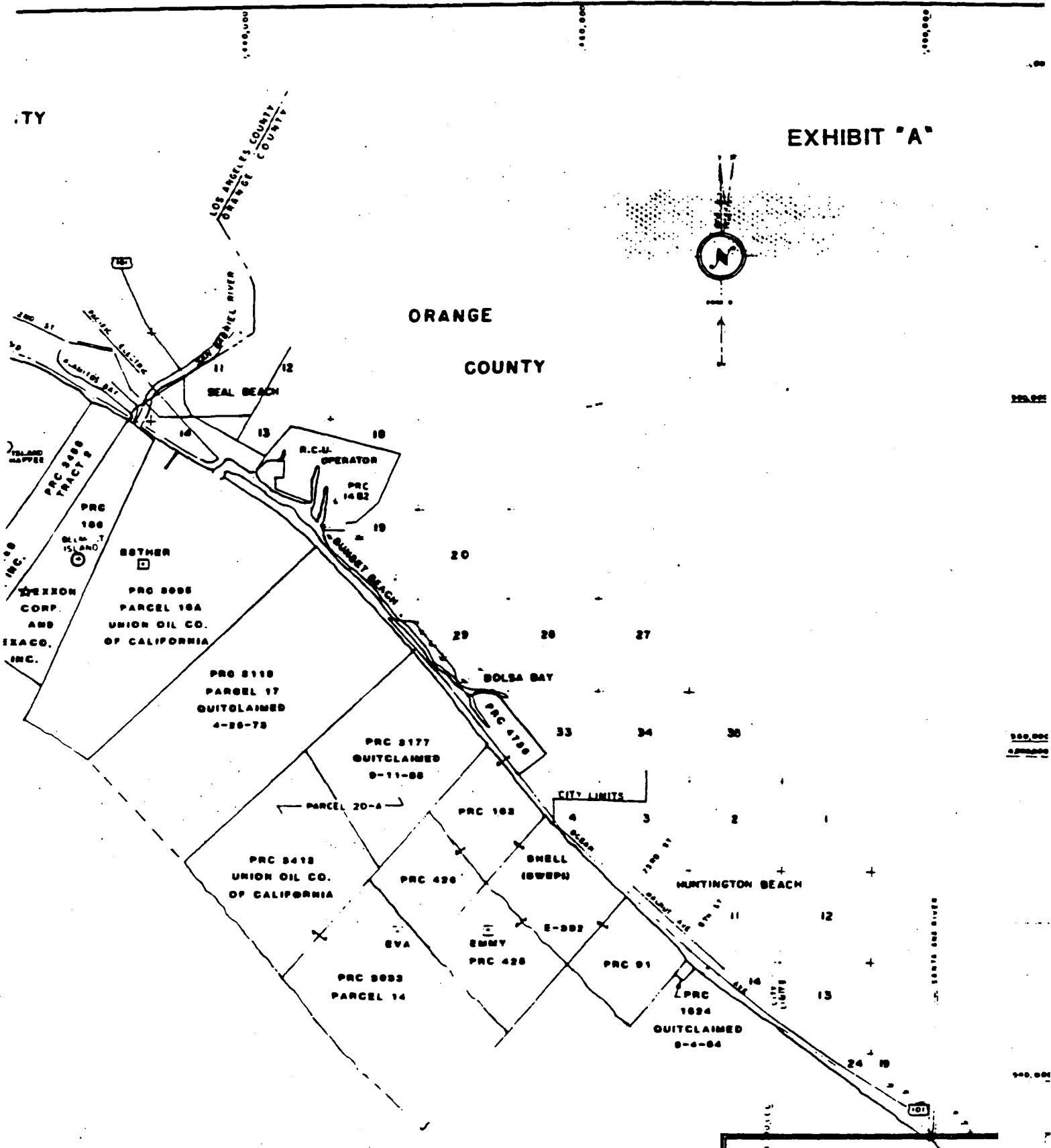
