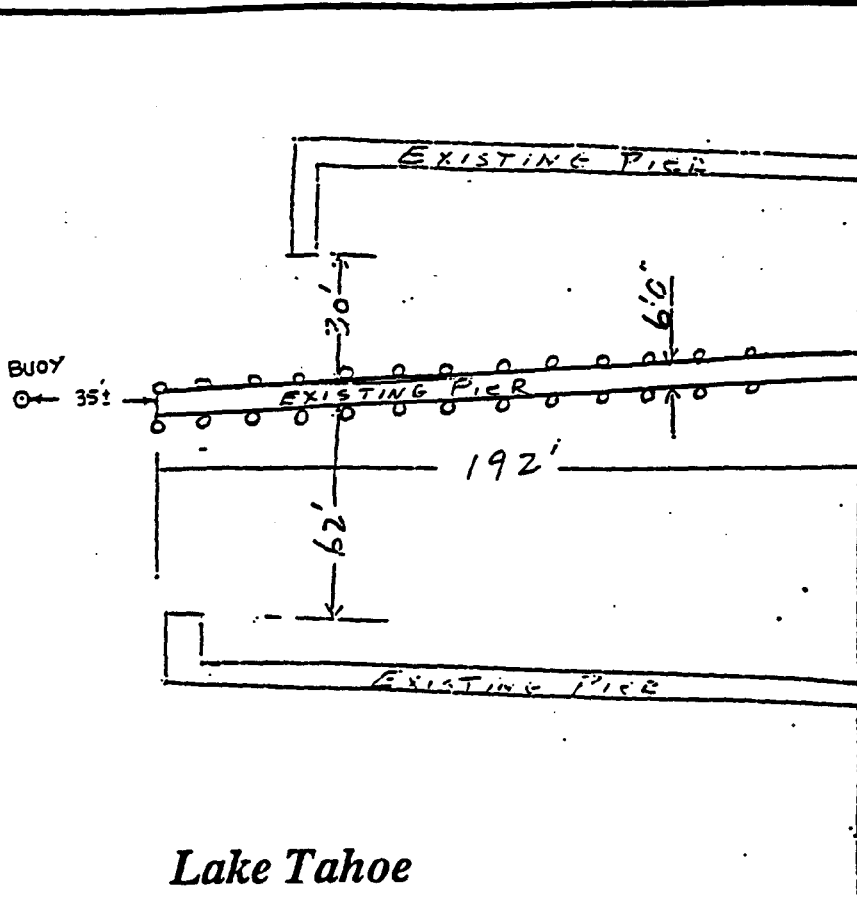

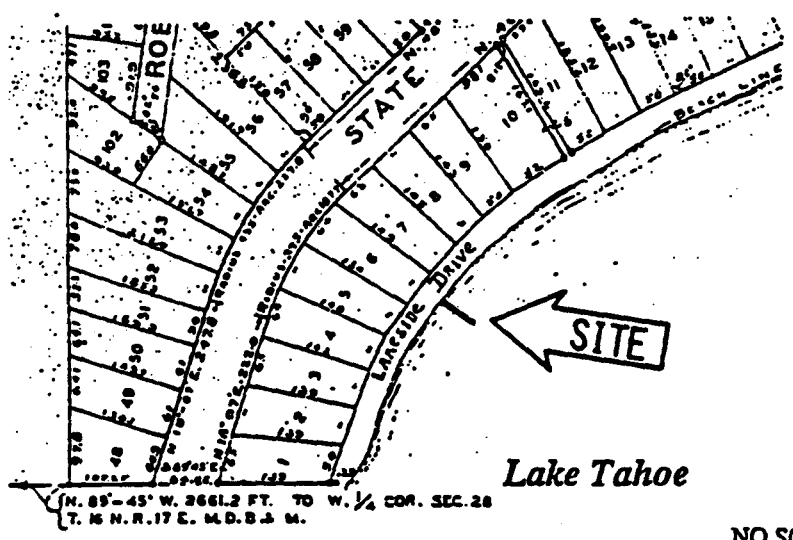

LOCATION MAP



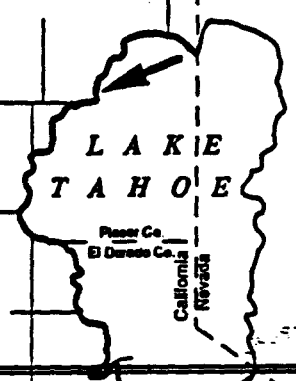
