RECREATIONAL PIER PERMIT

APPLICANTS:

LOCATION:

Submerged land in Donner Lake, Nevada County

LAND USE:

Construction and maintenance of a pier to be utilized for recreational boating.

PERMIT TERM:

Initial Period: Ten (10) years

CONSIDERATION:

Rent-free pursuant to Section 6503.5 of the P.R.C.

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Code Regs. 2003

APPLICANT STATUS:

Applicant is owner of the upland.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines, the staff has found that the activity is exempt from the requirements of the CEQA pursuant to 14 Cal. Code Regs. 15061 as a categorically exempt project. The project is exempt

under Class 3, New Construction of Small Structures, 2 Cal. Code Regs. 2905(c)(1).

Authority: P.R.C. 21084, 14 Cal. Code Regs. 15300, and 2 Cal. Code Regs. 2905.

2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
3. The permit is conditioned on the public's right of access along the shorezone below the high water line (Elevation 5935.80 feet) pursuant to the holding in State v. Superior Court (Fogerty), 2 Cal. 3d. 240 (9181), and provides that the Permittee must provide a reasonable means for public passage along the shorezone, including, but not limited to, the area occupied by the authorized improvement.

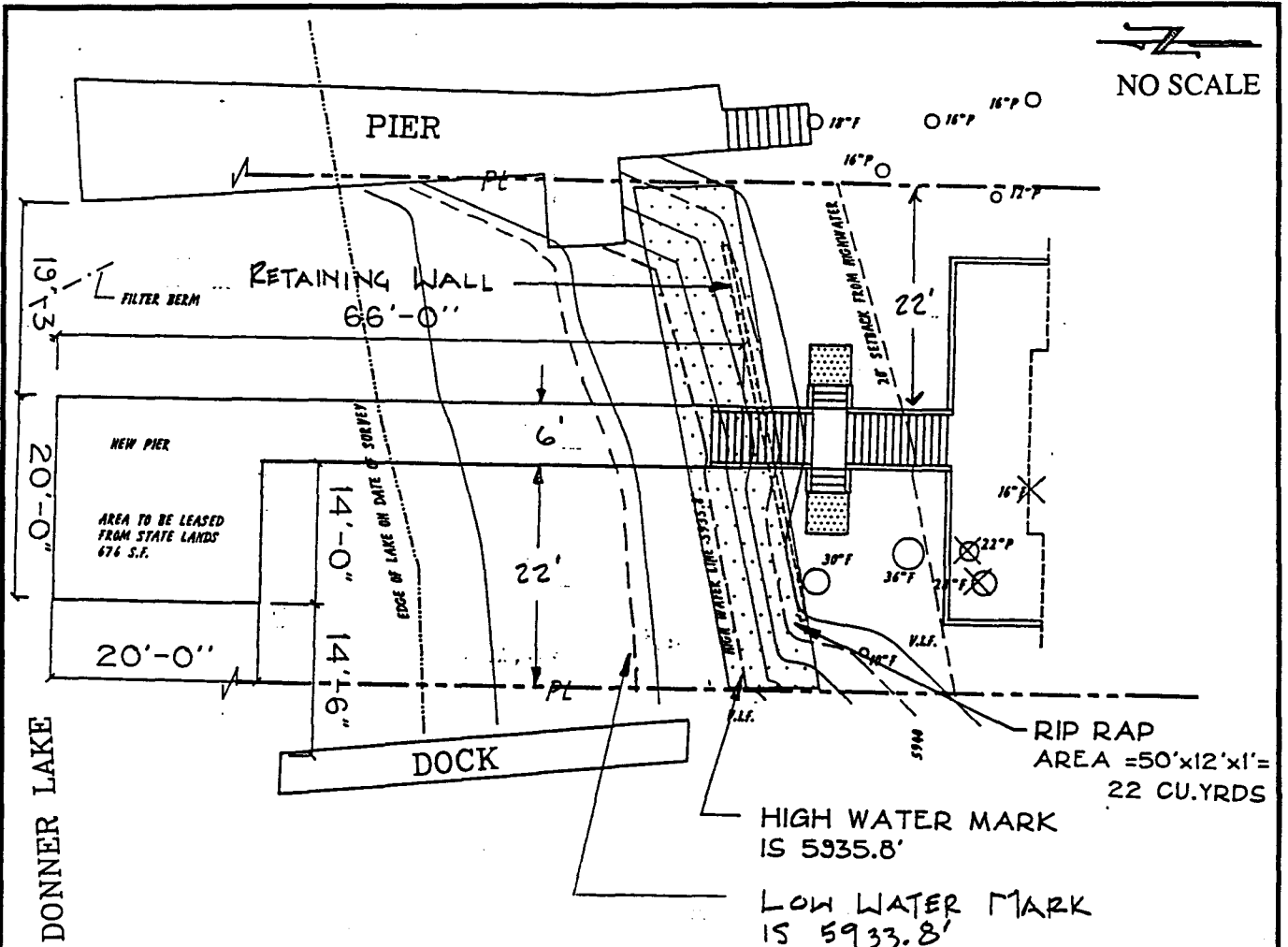
IT IS RECOMMENDED THAT THE COMMISSION:

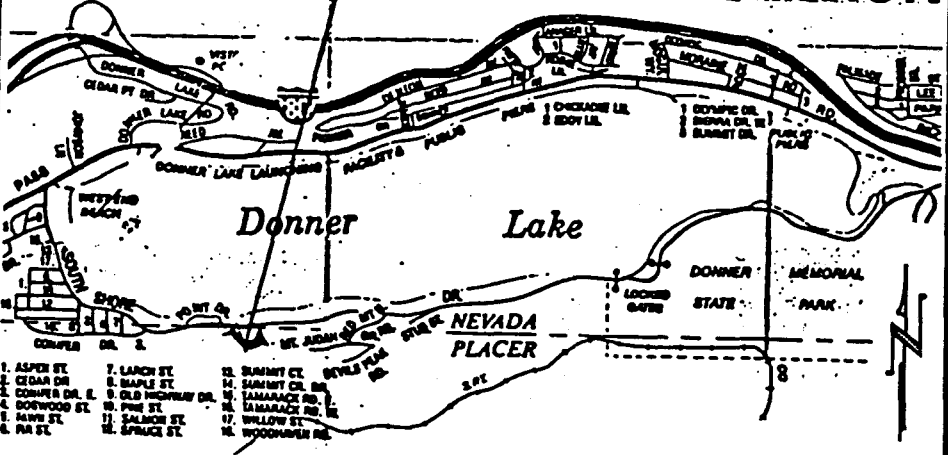
