- 1. FIND THAT AN ENVIRONMENTAL ANALYSIS DOCUMENT, EMERGENCY PERMIT NO. E-104, WAS PREPARED AND CERTIFIED FOR THE PROJECT BY THE SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION UNDER ITS CERTIFIED PROGRAM (14 CAL. CODES REGS. 15251 (H)), AND THAT THE COMMISSION HAS REVIEWED AND CONSIDERED THE INFORMATION CONTAINED THEREIN.
- 2. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEO.
- 3. AUTHORIZE ISSUANCE OF A DREDGING LEASE TO CECIL ROCHE, WORK TO BE COMPLETED NO LATER THAN MAY 15, 1994. SAID LEASE SHALL ALLOW DREDGING A MAXIMUM OF 700 CUBIC YARDS OF MATERIAL FROM STATE SOVEREIGN LANDS ALONG THE PETALUMA RIVER, AT CLOUDY BEND, SONOMA COUNTY. SUCH PERMITTED ACTIVITY IS CONTINGENT UPON APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS, OR LIMITATIONS ISSUED BY FEDERAL, STATE AND LOCAL GOVERNMENTS.
