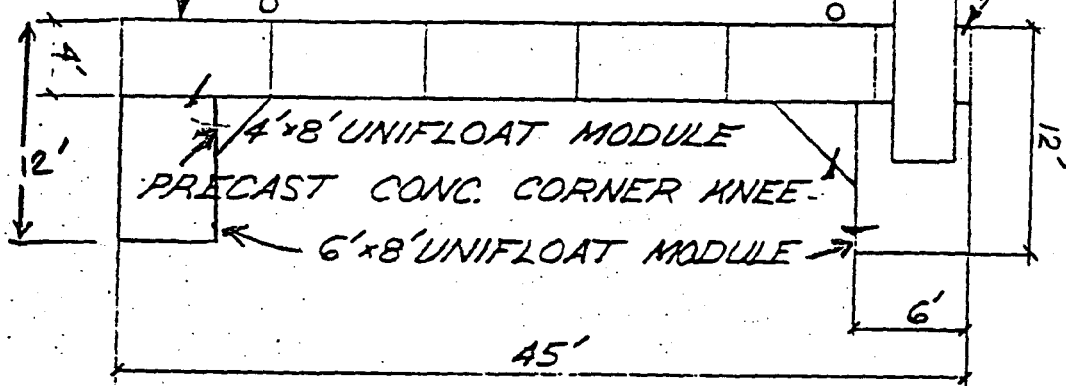

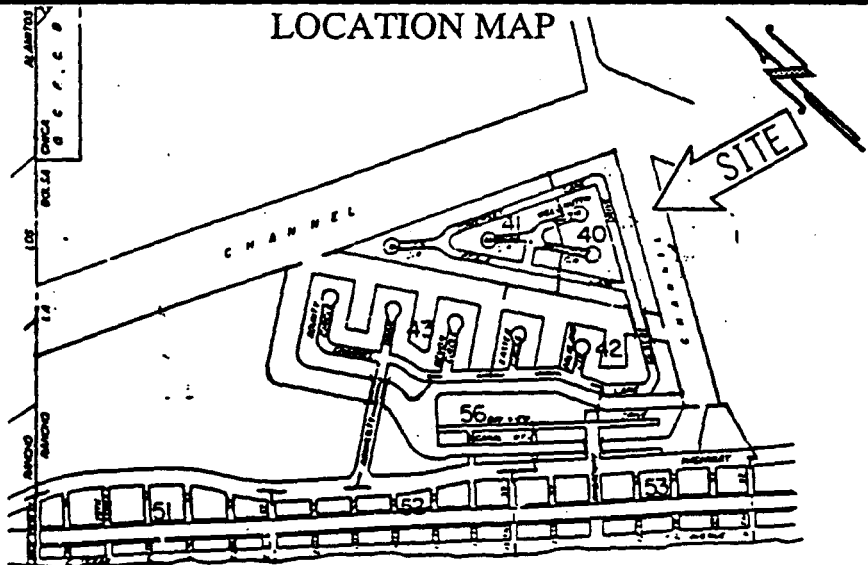
5'x8' UNIFLOAT MODULE
