THE ORIGINAL PERMIT AUTHORIZED THE CONSTRUCTION, OPERATION AND MAINTENANCE OF A BOAT LAUNCHING FACILITY. THE AMENDMENT WILL INCLUDE TWO 8 FT. X 80 FT. FLOATS WITH TWO 15 FT. LAUNCH LANES; BANK PROTECTION AND BANK RESTORATION; HANDICAPPED ACCESS; PICNIC AREA, AND RESTROOM.

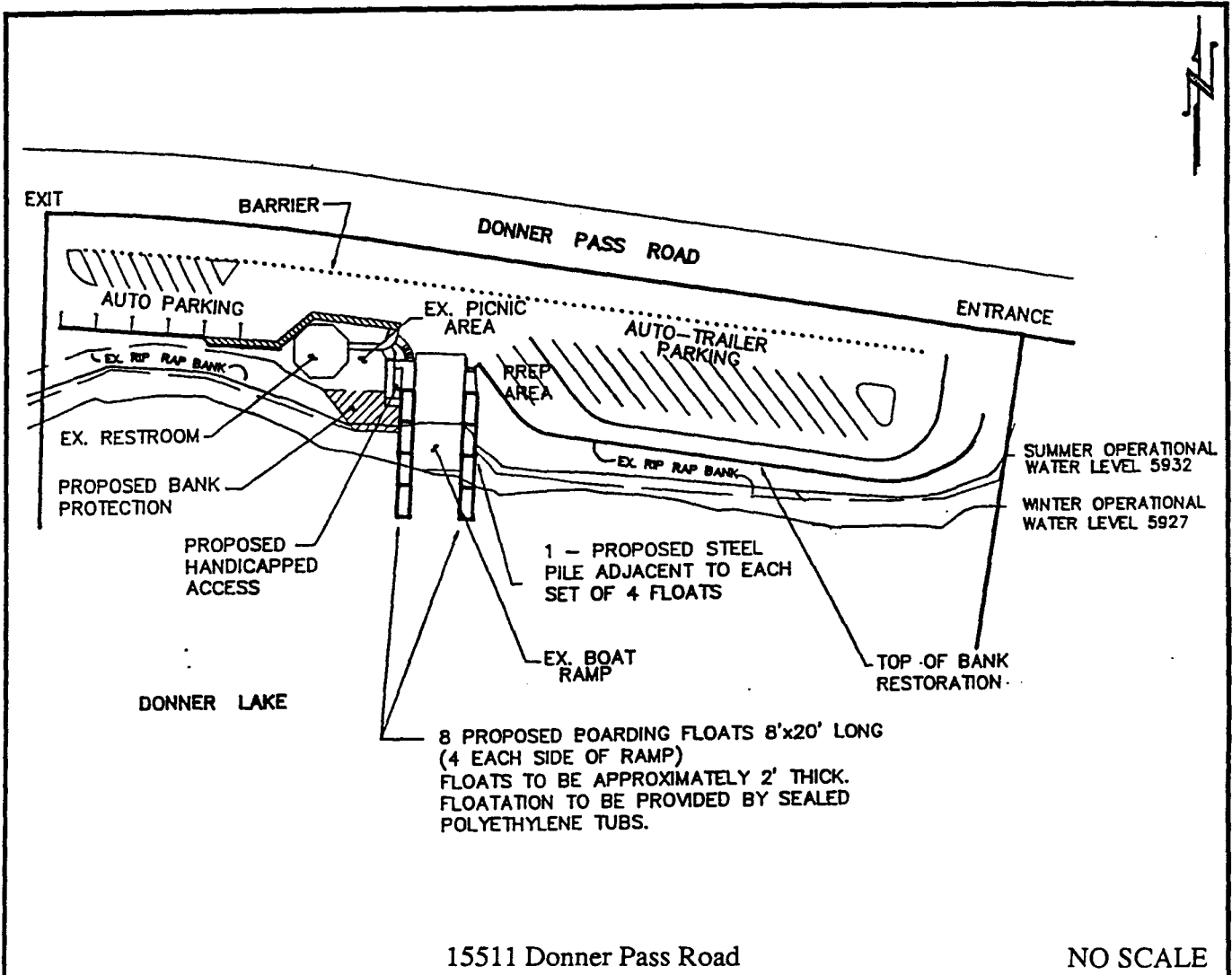

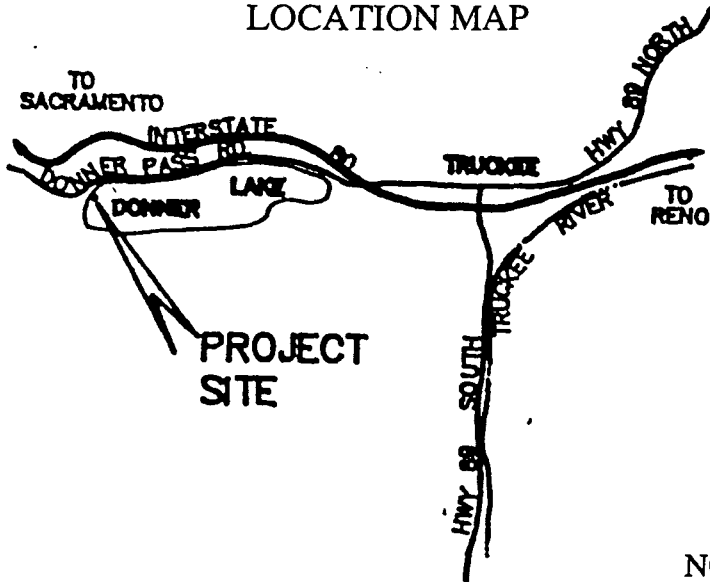
