### APPLICANT:

Southern Pacific Telecommunications Company 555 17th Street, 10th Floor Denver, Colorado 80202

## AREA, TYPE LAND AND LOCATION:

Parcels of tide and submerged land, located in numerous waterways including the Petaluma, Napa, and San Antonio Rivers and Hastings Slough; parcels located within the existing railroad right of way in Sonoma, Marin, Napa, Solano and Contra Costa Counties.

### LAND USE:

Installation, maintenance and operation of a fiber optic cable for telecommunications and cable television.

### PROPOSED LEASE TERMS:

Lease period:

25 years beginning December 21, 1994.

Surety bond: \$50,000.

Public liability insurance:

Combined single limit coverage of \$1,000,000.

### Consideration:

\$2,000 per annum; with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

## BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Code Regs. 2003.

## APPLICANT STATUS:

Applicant is permittee of upland.

### OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA under the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environmental. The staff believes there is no possibility that this project may have a significant effect on the environment.
