TERMINATION OF GENERAL LEASE - RIGHT OF WAY USE PRC 5740, AND
ISSUANCE OF A GENERAL LEASE - PUBLIC AGENCY USE FOR PRC 5740

OTHER PERTINENT INFORMATION:

On October 29, 1979, the Commission approved the issuance of
a 49-year General Lease - Right-of-Way Use PRC 5740.1 to
Mobil Oil Estates (Redwood) Limited (name was subsequently
changed to Redwood Shores, Inc.) for construction and
maintenance of two 36-inch diameter saltwater intake lines
in Belmont Slough, San Mateo County.

After construction completion, the City of Redwood City, per
Minute Order No. 83-86 dated June 7, 1983, accepted the
improvements for Shorebird Subdivision No. 1 which include
the intake lines within the lease premises, from Redwood
Shores, Inc. Although the City has taken over the
maintenance of the intake lines since 1983, it is now the
desire of Lessee to have this lease transfer to the City.

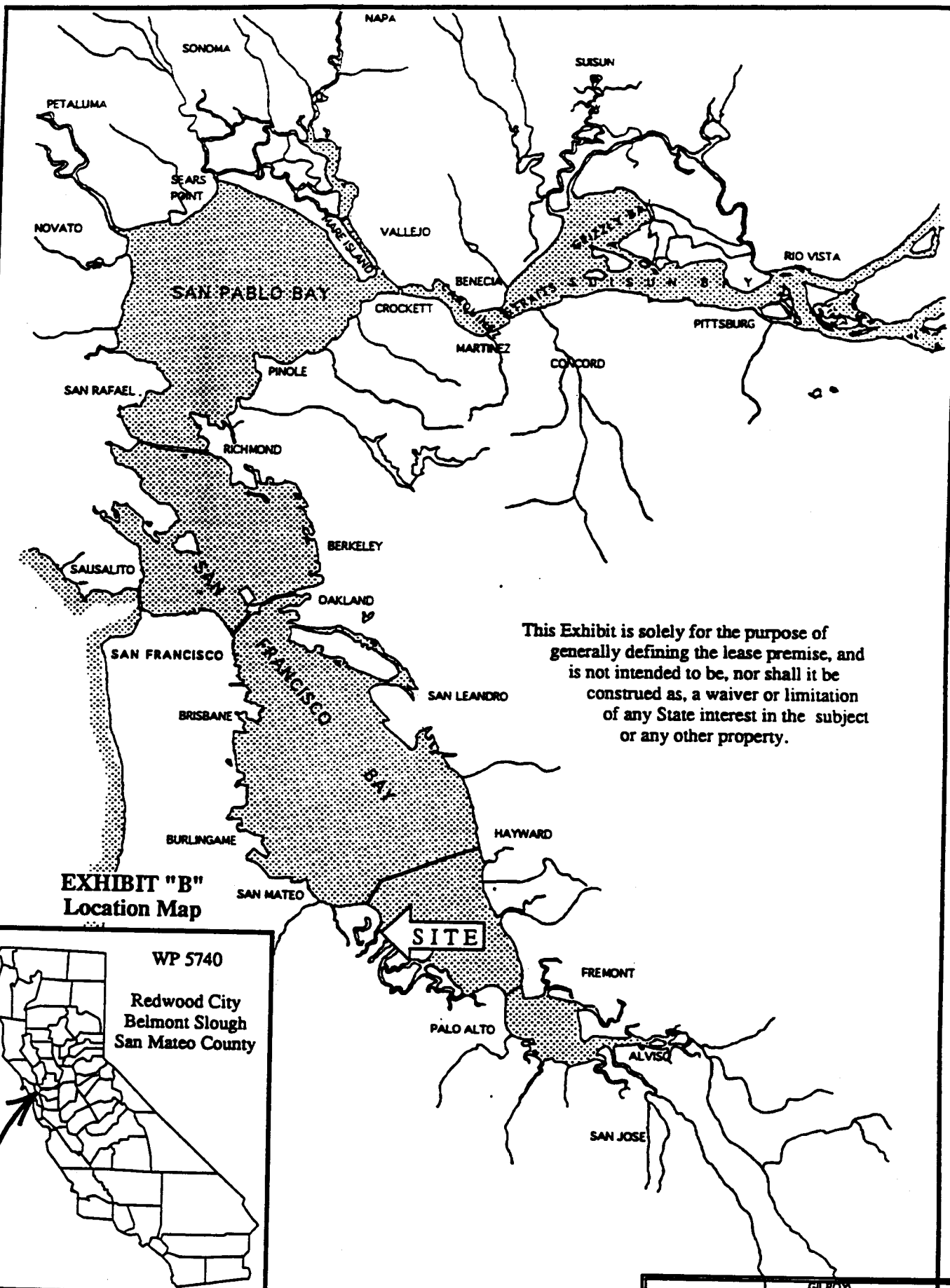
1. S 06° 08' 10" E, 102.90 feet; thence
