CESSION OF CONCURRENT CRIMINAL JURISDICTION AT FEDERAL PRISON CAMP, BORON, KERN COUNTY AUTHORIZATION TO CONDUCT PUBLIC HEARING

# BACKGROUND:

The United States exercises proprietary jurisdiction over the Federal Prison Camp at Boron, Kern County. By letter dated May 15, 1995 the Department of Justice has requested California cede concurrent criminal jurisdiction over this facility for five years.

California Government Code Section 126 authorizes the State Lands Commission to cede such jurisdiction if the following conditions, among others, are met:

- 1. The United States has in writing requested that the State cede jurisdiction;
- 2. The State Lands Commission has held a public hearing to determine whether it is in the State's best interests to cede the jurisdiction; and
- з. The United States has agreed to pay for the costs associated with the cession process.

The United States has made the written request for the cession and has agreed to bear the costs associated with the cession.

The Commissioners are requested to authorize the Executive Officer or his delegate to conduct the required public hearing to


