### **APPLICANT:**

UNOCAL Corporation 1380 San Pablo Avenue Rodeo, California 94572

#### AREA, TYPE LAND AND LOCATION:

Tide and submerged lands in San Pablo Bay, Davis Point, Contra Costa County.

#### LAND USE:

Maintenance dredge a maximum 90,000 cubic yards of material annually at the UNOCAL Marine Terminal at Davis Point, San Pablo Bay. Material will be disposed at the Army Corps of Engineers Carquinez Disposal Site (SF 9).

#### TERMS OF PROPOSED LEASE:

Lease period:

November 1, 1995 through July 31, 1998.

Royalty

No royalty will be charged.

\$0.25 per cubic yard for any material used for private benefit or commercial sale purposes.

#### PREREQUISITE CONDITIONS, FEES AND EXPENSES:

Filing and processing costs have been received.

such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

2. Pursuant to the Commission's delegation of authority and the State's CEQA Guidelines (14 Cal. Code REGS.. 15061), the staff has determined that this activity is exempt from the requirements of CEQA as a categorical exempt project. The project is exempt under Class 4, Minor Alteration to Land, 14 Cal. Code REGS.. 15304 (G).

Authority: Public Resources Code Section 21084 and 14 Cal. Code REGS.. 15300.

3. Staff and representatives of the UNOCAL Corporation are currently in negotiations which are intended to determine the terms and conditions for the continued operation of the UNOCAL Marine Terminal under a separate lease application. It is staff's intent to consolidate this dredging lease and the marine terminal lease upon the consideration of the latter by the Commission and, thereby, to address both activities under a single lease


