AMENDMENT GENERAL LEASE-INDUSTRIAL USE

California and Hawaiian Sugar Company, Inc.

PERTINENT INFORMATION:

Since the sugar refinery has been in operation, beginning in the early 1900's, while ships were discharging sugar, it was and still is common practice to clean their bilges and remove the sludge; lubrication oil and petroleum stores needed for the return voyage are added at the same time. On September 23, 1992, the Commission approved issuance of a new lease to C&H which prohibited shipping and transfer of petroleum products to operate the C&H facility. This action will allow for the continuation of transferring lubrication oil, petroleum stores, and residues containing oil; the authorization is limited only to ships loading and/or discharging sugar products.

At the present time, the "sludge" is removed from the ship through a 2 inch hose and is pumped into a 2,500 gallon hazardous waste collection tank truck. The trucks drive out onto the dock and park alongside the vessel on the C&H docks. The pumping is done at low pressure--approximately 40 psi-- in hoses which are tested certified annually by the U.S. Coast Guard. Camlocks are used on all fittings, the hoses are tied down, and drainage receptacles are placed under all connections. Plastic sheeting is also placed under the connection between the hose and the truck. Following discharge from the vessel, the "sludge" is removed via the truck and disposed of at a licensed facility.

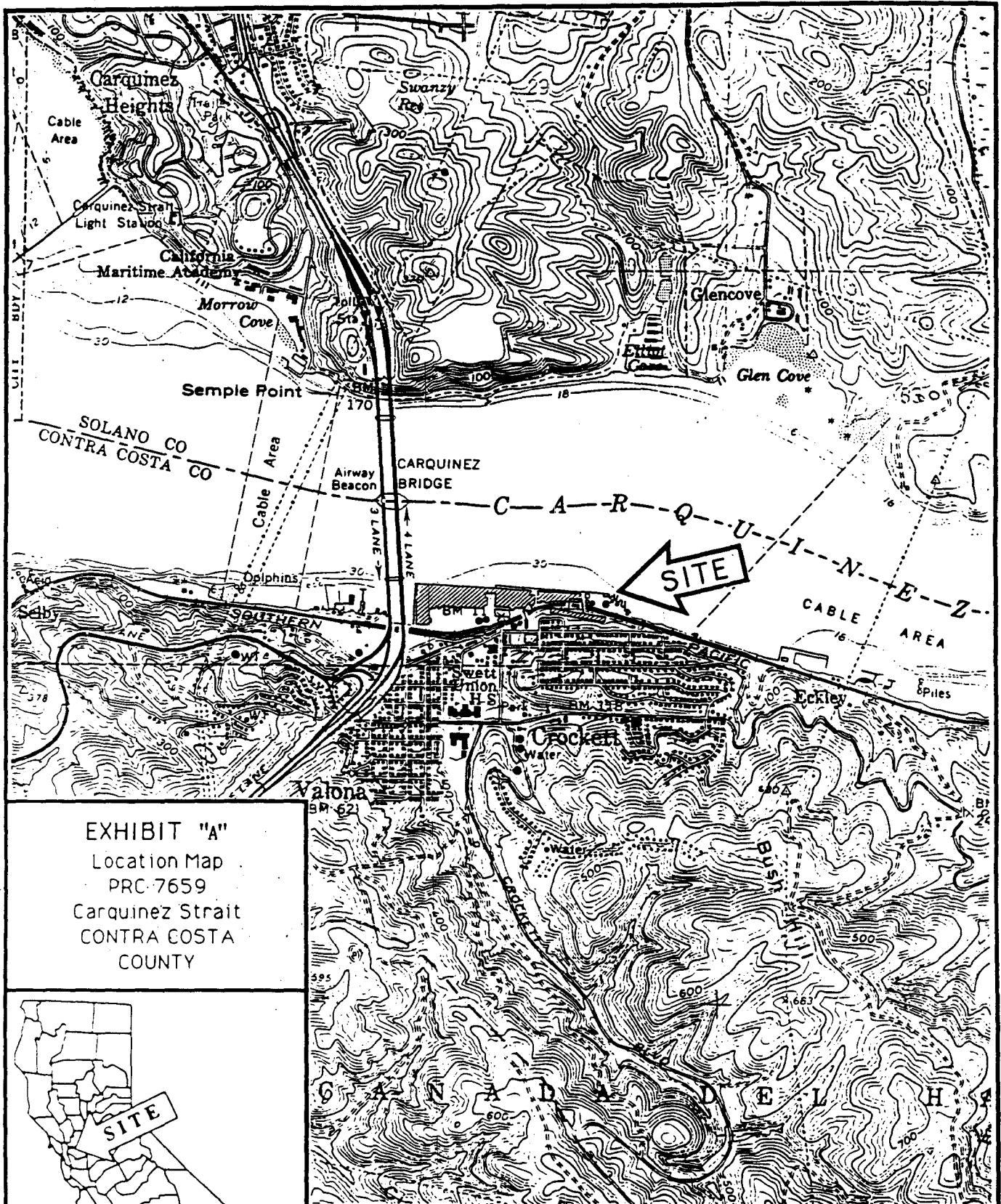


EXHIBIT "A"
