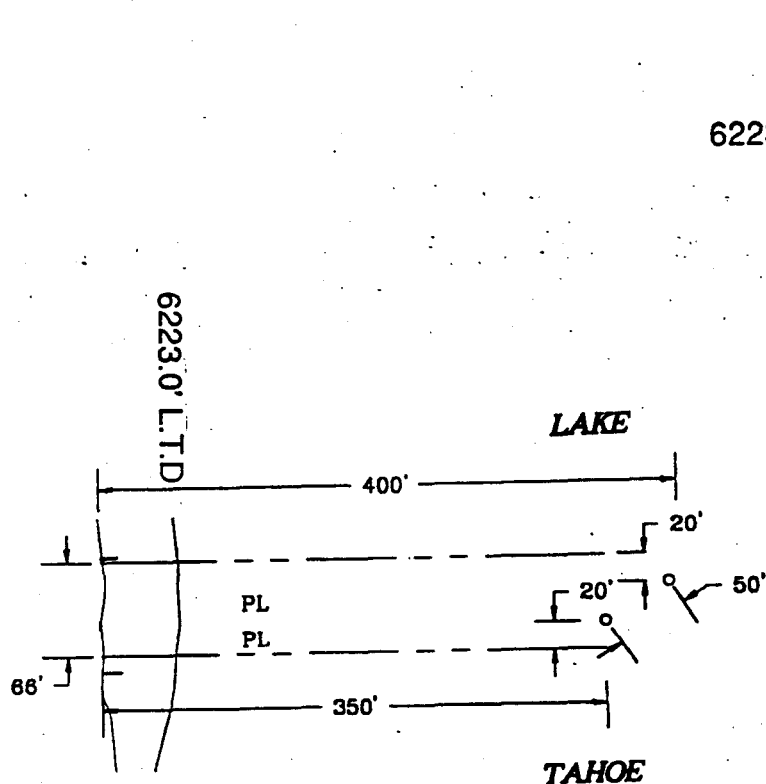

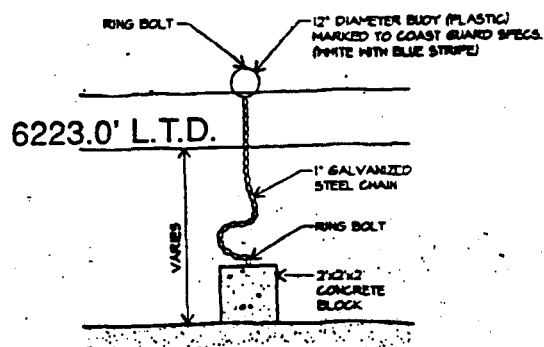

BUOY PLAN

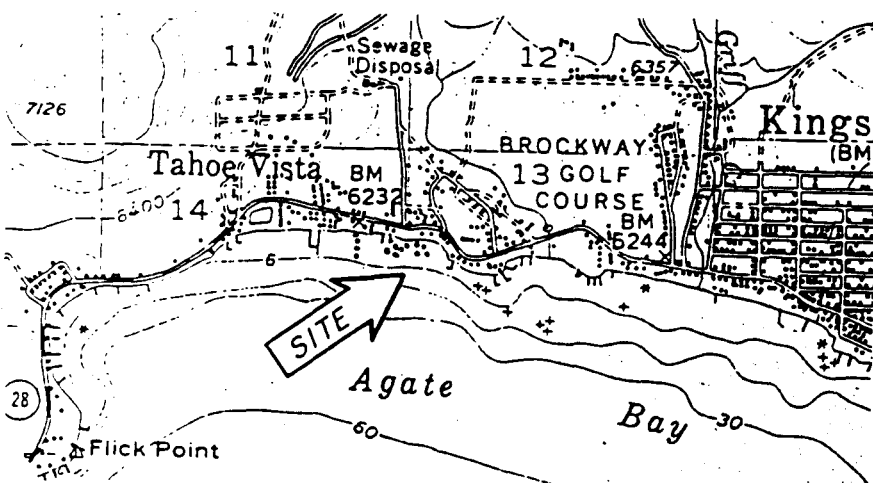


BUOY DETAIL

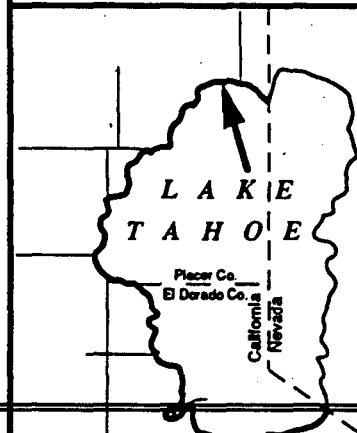
