On September 14, 1988, the Commission approved a 10-year lease to Robert H. and Margret G. Pelham (C44) for two floating boat docks in the Sacramento River. Mr. Pelham informed staff on May 14, 1995 that one of his docks was destroyed due to last winter's storms, and he would like staff to re-assess his annual rent to reflect the one remaining dock.
