AMENDMENT OF GENERAL LEASE - RECREATIONAL USE

LESSEE:

Elizabeth C. Lewis Trust
Roberta L. Patterson Trust
Edward C. Lewis

LOCATION:

A .397-acre parcel of submerged land located in the bed of Lake Tahoe, Placer
County.

OTHER PERTINENT INFORMATION:

This lease was originally issued on August 1, 1975 for ten years and renewed on
August 1, 1985 for 15 years to Elizabeth C. Lewis. The lease was amended on
June 30, 1992, to allow for reconstruction of an existing pier and installment of a
low-level boatlift. Reconstruction limiting dates were June 15, 1992 to
September 30, 1993. Lessee was unable to meet limiting dates and has
requested new dates of July 1, 1996 to October 1, 1996 or July 1, 1997 to
October 1, 1997.

CALENDAR ITEM NO. **C09** (CONT'D)

This amendment will also ratify a previous unauthorized assignment to the Elizabeth C. Lewis Trust and approve the current assignment of one-half of the Trust's interest in the lease to the Roberta L. Patterson Trust and Edward C. Lewis as tenants in common.

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines, 14 Cal. Code Regs.15015, the staff has prepared a Proposed Negative Declaration identified as Environmental Impact Report Negative Declaration 591, State Clearinghouse No. 92052040. Such Proposed Negative Declaration was prepared and circulated for public review pursuant to the provisions of CEQA.

Based upon the Initial Study, the Proposed Negative Declaration, and the comments received in response thereto, there is no substantial evidence that the project will have a significant effect on the environment. (14 Cal. Code Regs.15074 (b))

A Mitigation Monitoring Plan has been prepared in conformance with the provisions of the CEQA. (Section 21081.6, Public Resources Code)

The Commission adopted such documents on June 30, 1992.

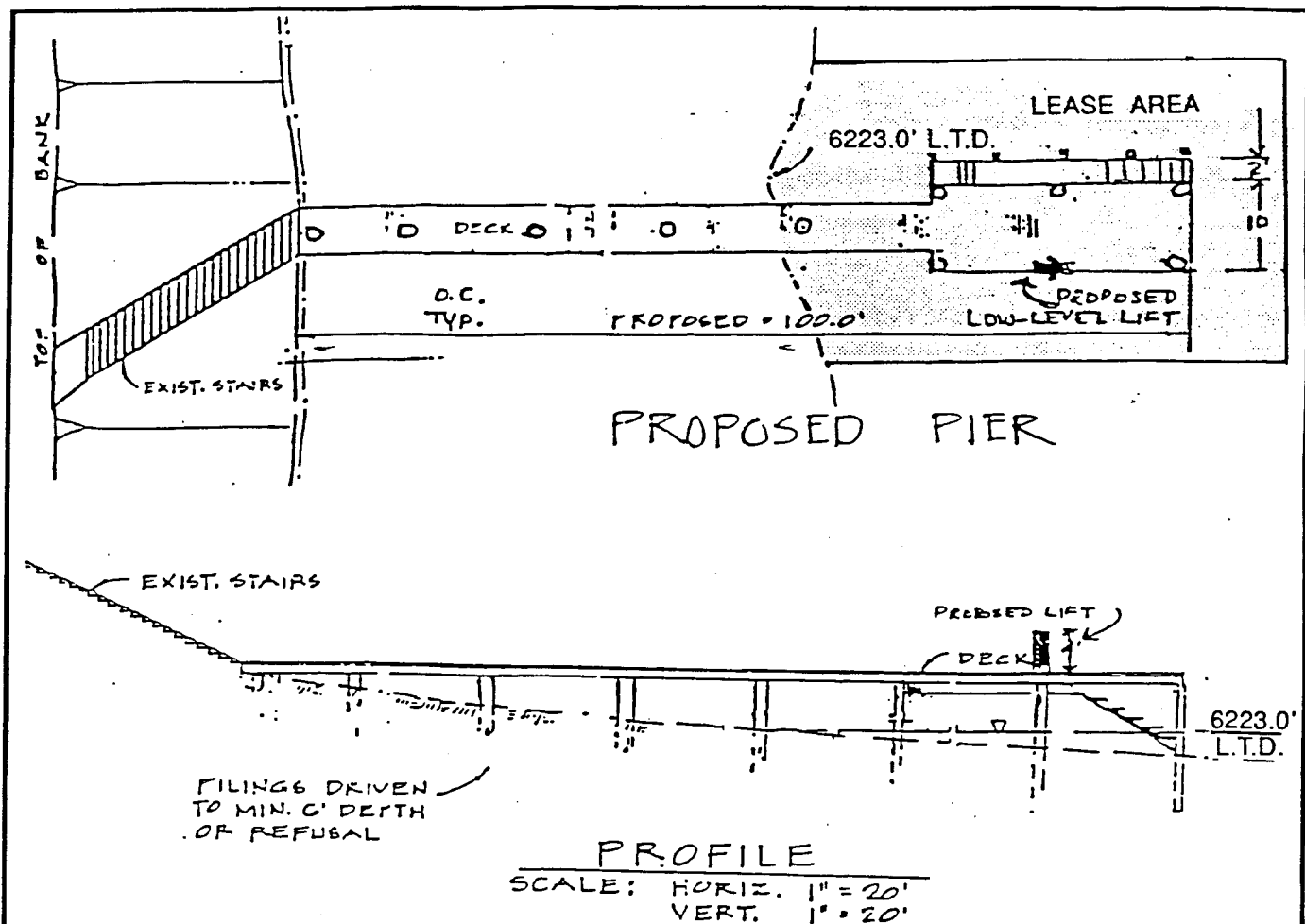

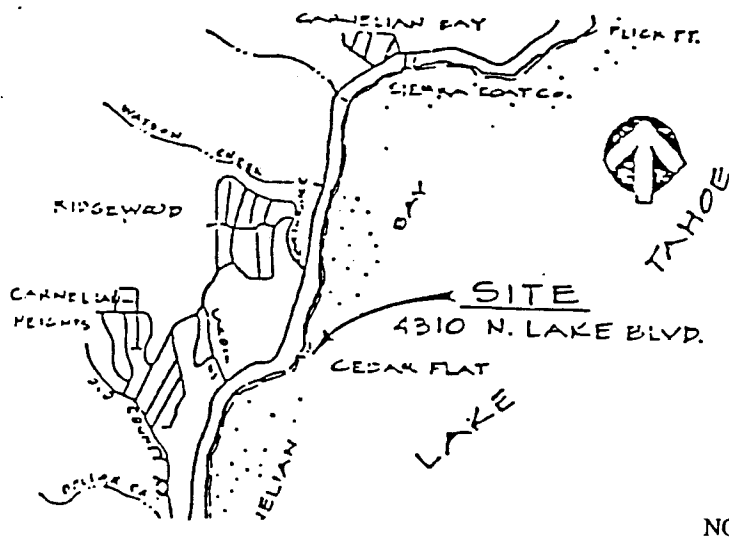
AUTHORIZATION:

1. AUTHORIZE ISSUANCE TO THE ELIZABETH C. LEWIS TRUST, THE ROBERTA L. PATTERSON TRUST, AND EDWARD C. LEWIS, OF AN AMENDMENT TO LEASE PRC 5401.1 FOR AN EXTENSION OF THE TIME PERIOD FOR RECONSTRUCTION OF THE PIER AND INSTALLATION OF A LOW-LEVEL BOATLIFT AS SHOWN ON EXHIBIT 'A'. NEW CONSTRUCTION DATES ARE JULY 1, 1996 THROUGH OCTOBER 1, 1996, OR JULY 1, 1997 THROUGH OCTOBER 1, 1997.
2. RATIFY A PREVIOUSLY UNAUTHORIZED ASSIGNMENT TO THE ELIZABETH C. LEWIS TRUST AND AUTHORIZE THE ASSIGNMENT OF ONE HALF OF THE TRUST'S INTEREST IN THE LEASE TO THE ROBERTA L. PATTERSON TRUST AND EDWARD C. LEWIS AS TENANTS IN COMMON.

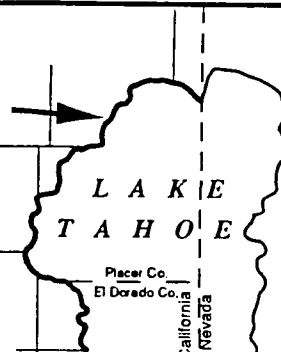
