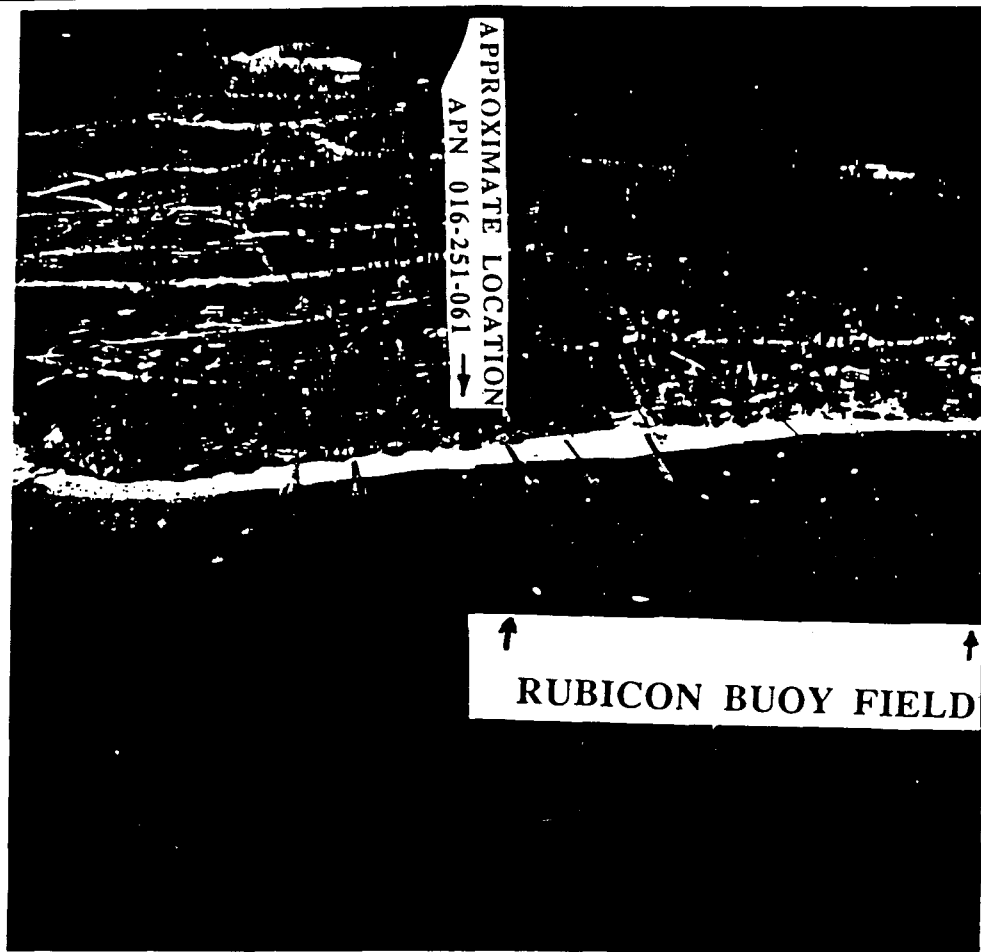

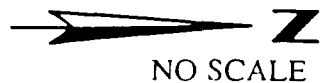

LOCATION MAP

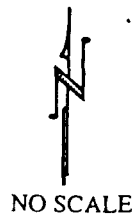
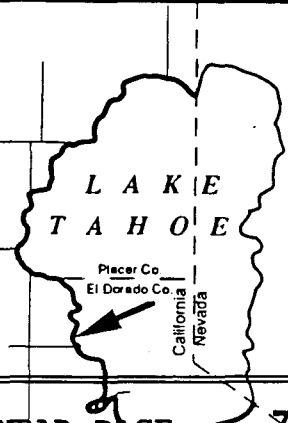
