**APPROVE THE AWARD OF THE CRUDE OIL SALES CONTRACT  
BY THE CITY OF LONG BEACH FOR THE CITY'S WORKING INTEREST  
SHARE OF CRUDE OIL ALLOCATED TO TRACTS WITHIN  
THE FAULT BLOCK IV UNIT AND FAULT BLOCK V,  
RANGER ZONE UNIT, WILMINGTON OIL FIELD,  
LOS ANGELES COUNTY**

**AREA, TYPE LAND AND LOCATION:**

Various tracts within the Fault Block IV Unit and Fault Block V Ranger Zone Unit,  
Wilmington Oil Field, Los Angeles County, as detailed on Exhibit "A".

**LAND USE:**

Oil and gas development and production.

**BACKGROUND:**

The State Lands Commission (SLC) approved, at its October 17, 1995 meeting, the specifications proposed by the City of Long Beach (City) for the sale of the City's working interest share of crude oil allocated to various tracts, including some tidelands tracts, within the Fault Block IV Unit and Fault Block V Ranger Zone Unit, Wilmington Oil Field, Los Angeles County. The City published a notice inviting bids in the Long Beach Press-Telegram on October 18 through

October 20, 1995, and sent bid packages to known interested bidders. A bid opening was held on November 8, 1995. Exhibit "B" shows the results of the bidding.

Commission staff recommends approval of the awarding by the City of the crude oil sales contract for tracts within Fault Block IV Unit and Fault Block V Ranger Zone Unit, Wilmington Oil Field to the highest responsible bidder identified on Exhibit "B".
