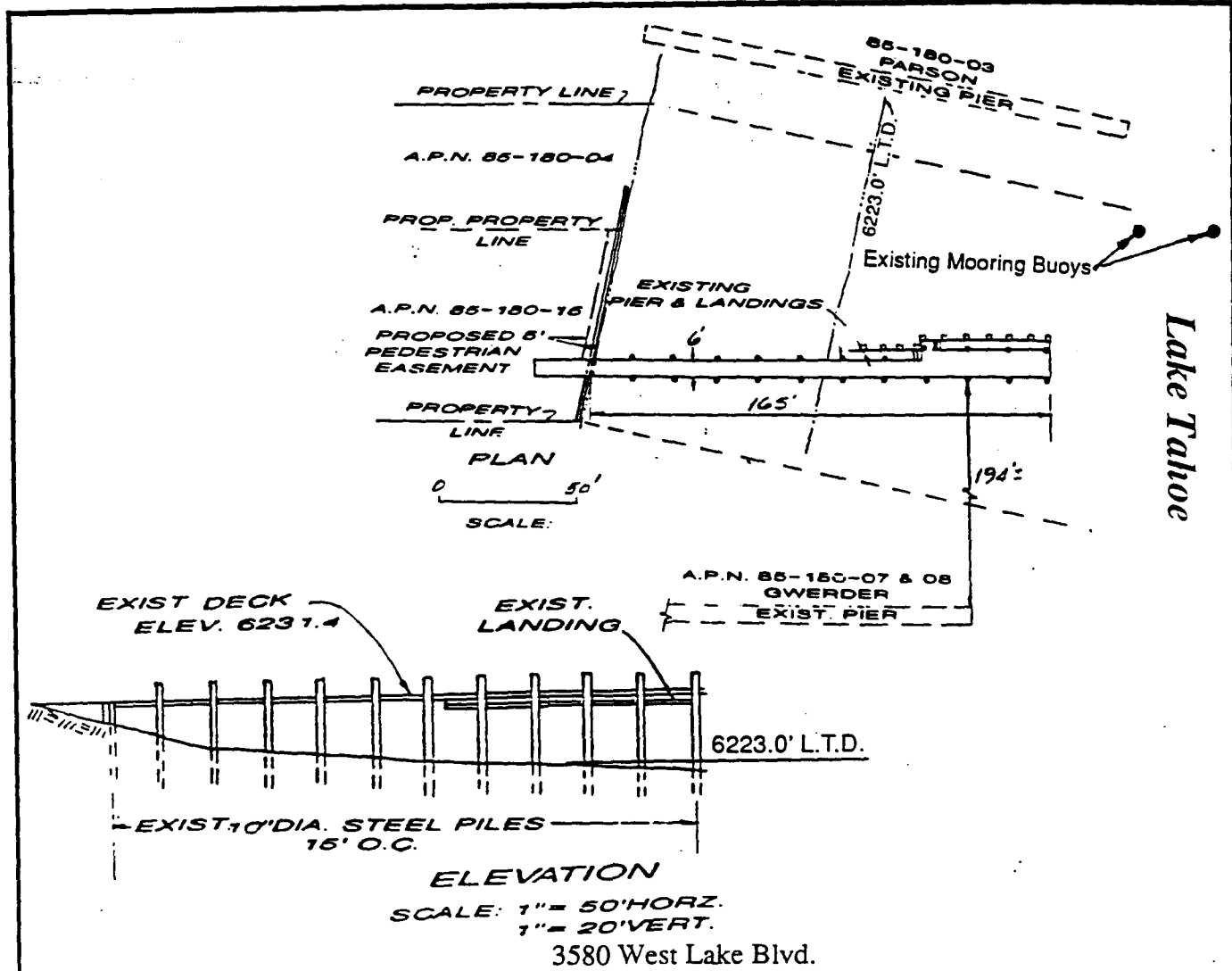

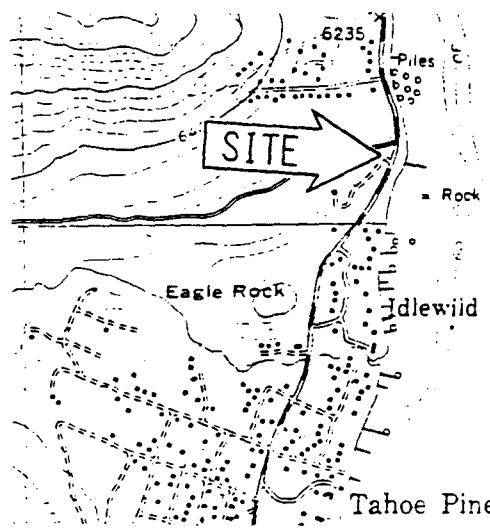

Lake Tahoe

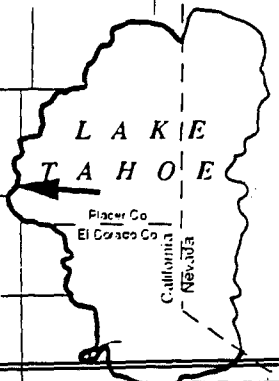
**LOCATION MAP**
