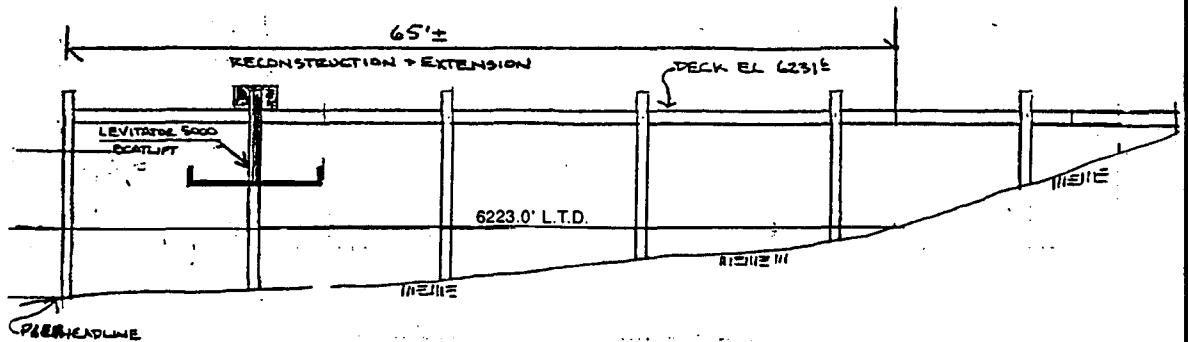
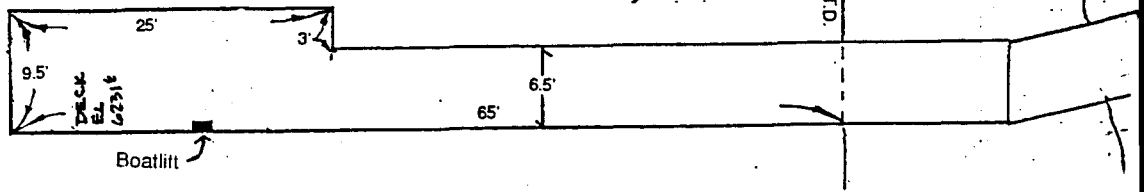

PLAN VIEW

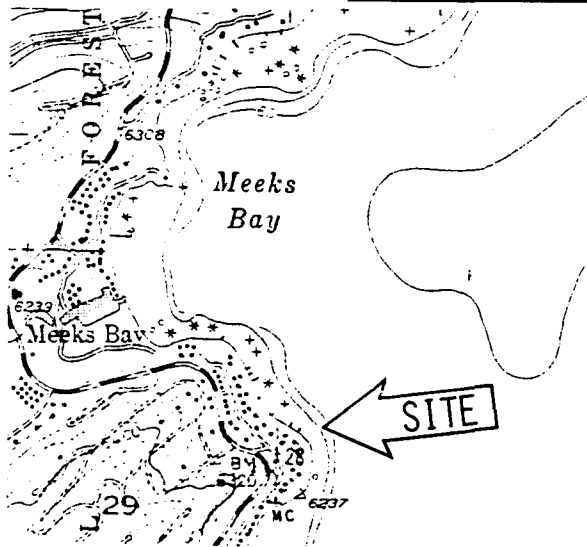


NORTH ELEVATION VIEW

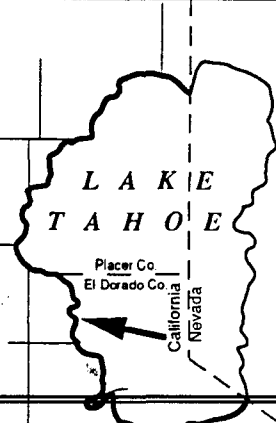
