SP AGREES TO SUBMIT AN ANNUAL CERTIFIED FINANCIAL REPORT AND OTHER FINANCIAL INFORMATION RELATING TO THE PROGRAM; AND IN THE EVENT THE STATE FEELS SP IS UNABLE TO MEET ITS DEDUCTIBLES, IT RESERVES THE RIGHT TO REQUIRE THAT SP PROVIDE EVIDENCE OF INSURANCE COVERAGE FROM A PROVIDER ACCEPTABLE TO THE STATE.
