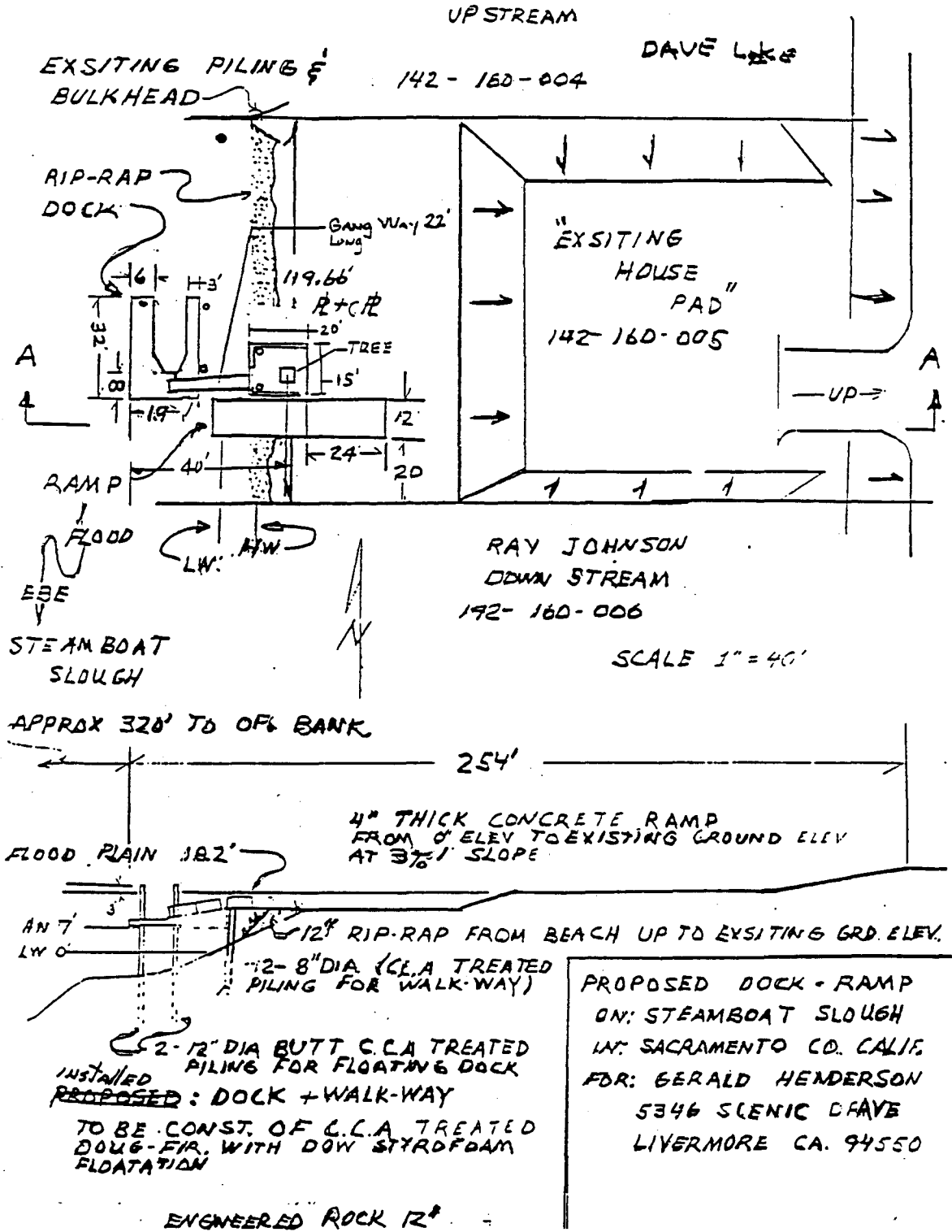
INVENTORY FINDING:

FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO PUBLIC RESOURCES CODE SECTIONS 6370, ET SEQ.

AUTHORIZATION:

AUTHORIZE ISSUANCE TO GERALD W. AND PAULA C. HENDERSON OF A TEN-YEAR GENERAL LEASE - PROTECTIVE STRUCTURE AND RECREATIONAL USE, BEGINNING JUNE 1, 1996; WITH NO MONETARY CONSIDERATION FOR THE BOAT DOCK, GANGWAY AND RAMP PURSUANT TO PUBLIC RESOURCES CODE SECTION 6503.5; AND THE PUBLIC USE AND BENEFIT, WITH THE STATE RESERVING THE RIGHT TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST FOR THE BANK PROTECTION; FOR THE CONTINUED USE AND MAINTENANCE OF AN EXISTING 19 FT. X 32 FT. SINGLE-BERTH FLOATING DOCK, 22 FT. LONG GANGWAY, AND APPROXIMATELY 60 CUBIC YARDS OF RIPRAP PLACED ALONG SHORELINE AND INTEGRATED LAUNCH RAMP FOR BANK EROSION CONTROL; ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

Area to be leased lies directly beneath dock, ramp, riprap, and walkway, plus a necessary use area 10 feet in width around the entire dock and walkway. **EXCEPTING THEREFROM** any portion lying above the ordinary high water mark.

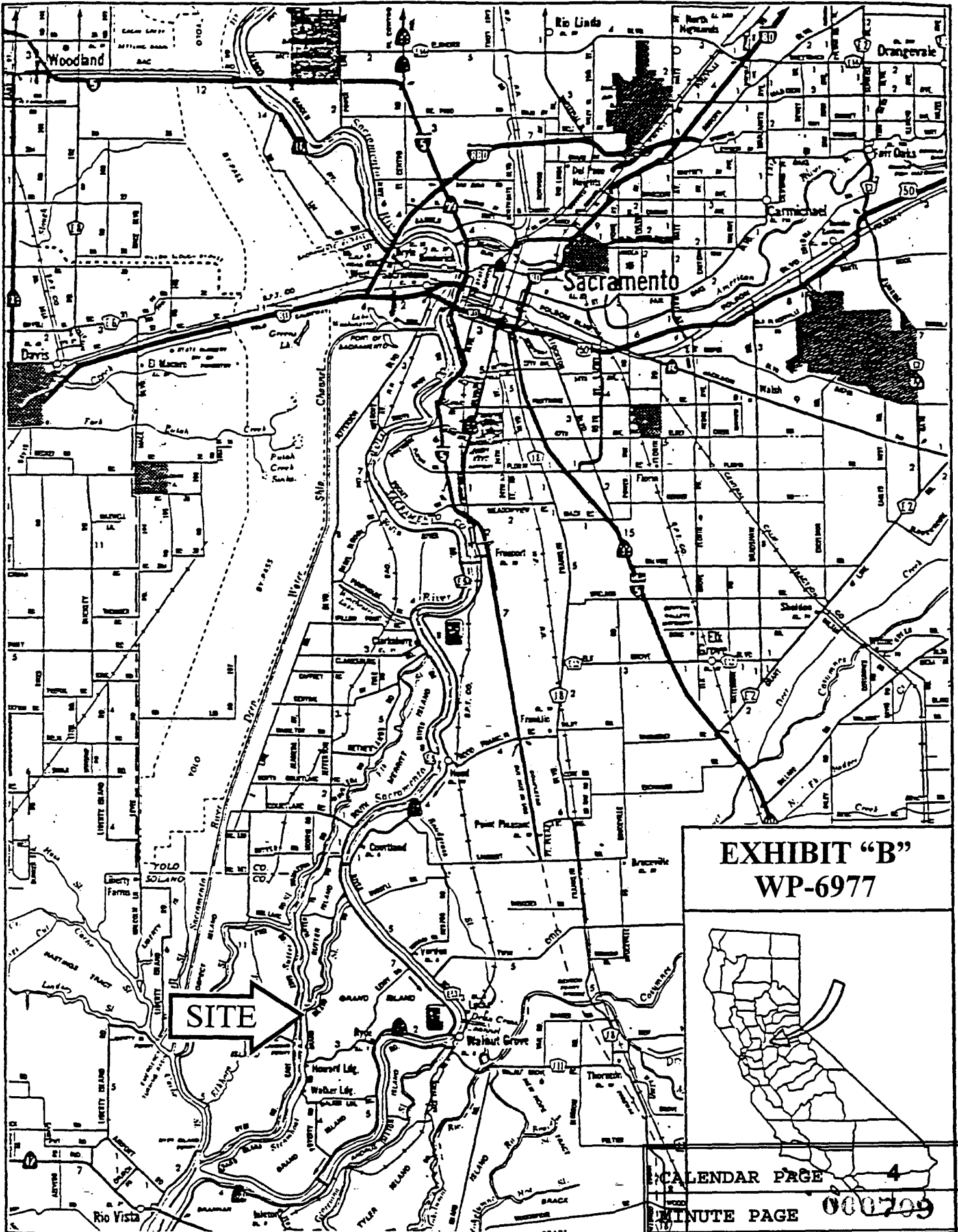
